## ROAD &amp; BRIDGE

Don Neuman, Bart Evans and Allen Mace, representing the Road & Bridge Department appeared before the Board.

The above representatives discussed maintenance and access on the Miller Hill Road with the Commissioners and County Sheriff, Jerry Colson.

September 19, 1995

Mace and Evans reported on their recent survey of the Ryan Park Commons in connection with the proposed Ryan Park Fire Station. Road & Bridge officials will meet with the Ryan Park Homeowners Association to determine the exact location and acreage to be used for the construction.

Carbon County School District Two has expressed an interest in using the Road & Bridge fuel pumps in Hanna. The Commissioners agreed to consider entering into an agreement with the school district for that purpose.

COMMUNITY SERVICE BLOCK GRANT HEARING

A hearing was held at 11:00 a.m. to receive applications for Community Service Block Grant funds awarded to Carbon County Government in the amount of \$42,404. Requests were received as follows:

\$30,000 requested by Carbon County Public Health Services  
for emergency health care

\$ 8,401 requested by Carbon County Public Health Services  
for parenting education

\$ 5,000 requested by Western Wyoming Family Planning for exam and lab fees.

A motion was made by Fleming, seconded by Graalman and carried to approve \$29,003 for emergency health care, \$8,401 for parenting education, and \$5,000 for exam and lab fees to be funded through the Community Service Block Grant (CSBG) program.

Genevieve Luallen, director of Carbon County Public Health Services, presented a needs assessment report she compiled identifying the needs of low income citizens in Carbon County. The report is a new requirement for the CSBG program and serves as a management tool to assist the Commissioners in deciding beneficiaries of the funding provided through the program.

A motion was made by Fleming, seconded by Graalman and passed to adopt the Carbon County Needs Assessment Report presented by Luallen.

## EMPLOYEE HEALTH AND LIFE INSURANCE

Ray Christoffersen, President of Centennial Employee Benefit Consultants, Inc. reviewed the bid listing and comparisons resulting from the recent call for bids to provide health and life insurance for employees of Carbon County Government. Christoffersen, serving in the capacity of a consultant hired by the Board of Commissioners, presented his recommendations. The Board took the matter under advisement.

A special meeting of the Board of Commissioners was set for Monday, September 25, 1995 at 7:30 p.m. to award the insurance bid. The meeting will be held in the Commissioner's Meeting Room of the Courthouse, Rawlins, Wyoming.

## COURTHOUSE

Bill Shelton, sales representative for Johnson Controls, Inc., presented a contract renewal for maintenance of heating controls in the Courthouse. The three year contract increased the annual rate from the present \$1,004 to \$1,320 for the year beginning October 1, 1995, \$1,342 for the year beginning October 1, 1996 and \$1,368 for the year beginning October 1, 1997.

A motion was made by Fleming, seconded by Graalman and passed to enter into a three year contract with Johnson Control, Inc. for the maintenance of heating controls in the Carbon County Courthouse.
