The board acknowledged receipt of an application for private road from petitioners Philip A. Card and Raydeane Card.

## FOREST ROAD PATROL

A motion was made by Fleming, seconded by Graalman and unanimously carried to enter into an agreement with the U.S.D.A. Forest Service. The agreement provides continuing law enforcement patrol of Forest Service property by the Carbon County Sheriff initially contracted June 20, 1981.

## CARBON COUNTY SENIOR SERVICES

A motion was made by Fleming, seconded by Graalman, and unanimously carried to approve the appointment of Jethred (Jackie) McMorrine as Hanna area representative on the Carbon County Senior Services Board.

## PLANNING

Jim Pedersen, Planning Director, reported on the Planning Commission meeting held the morning of November 5, 1996 in Suite 368 of the Carbon Building.

A motion was made by Graalman, seconded by Fleming, and unanimously carried to approve Case File#96-11, Jim & Alice Woodward (rezone from RAM to HB, 3.0 acres, North of Saratoga, off Highway 130).

A motion was made by Fleming, seconded by Graalman, and unanimously carried to approve Case File#96-12, Sierra Madre Land Company (rezone from RAM to R, 20 parcels, 3 to 24 acres, Sierra Madre Subdivision).

A motion was made by Graalman, seconded by Fleming, and unanimously carried to approve Case File #96-13, Alfred F. Gort (rezone from RAM to R, Lot 37, 4.56 acres, Sierra Madre Subdivision) with the stipulation of one cabin on this lot.

A motion was made by Fleming, seconded by Graalman, and carried to enter into executive session to discuss personnel (5:00 p.m.).


A motion was made by Graalman, seconded by Fleming, and carried to come out of executive session.
