Maintaining current number of EMT's in Encampment is a concern of the community. There is a need to recruit more EMT's and compensate them for making runs to Rawlins. Another concern of the community is improving services and maintenance of the Encampment Branch Library.

Gary Graalman made a motion and seconded by Artlin Zeiger to change polling locations as follows:


MUDDY GAP - From Three Forks Service to Frank Erickson's home
