The following letter was given to W.E. Harshman by Cindy Baldwin, County Treasurer, to inform the Commissioners of her role as payer of litigation costs in regards to the UPRC vs Wyoming Counties. The letter is as follows:

RE: UPRC vs Wyoming Counties, Litigation Costs

In my role of payer of litigation costs in the UPRC litigation, I am enclosing copies of the invoices to be paid and the new percentages to be used in these calculations.

At the present time, there are only three counties still involved in the litigation, Carbon, Crook and Uinta. Wyoming Royalties, Inc. has represented Uinta and Carbon County and Rocky Mountain Auditing has represented Crook County. While the law firm of Herschler, Freudenthal, Salzburg, Bonds & Zerga, P.C., have represented all three.

We have two bills from Wyoming Royalties, Inc. totaling \$3,298.13, which will be paid by Uinta and Carbon Counties at the respective percentage rates of 65.50% and 34.50%. Therefore, Carbon County's dollar amount for Wyoming Royalties is \$1,137.85.

Salzburg's firm has two bills for March 97 through April 30, 1997 totaling \$896.00. These invoices will be paid by all three counties, Carbon, Crook and Uinta with the percentages respectively Carbon 30.89%, Crook 10.45% and Uinta 58.66%. Using these percentages, Carbon County's dollar amount due on Salzburg's bill is \$276.77. With the combination of these two figures, Carbon County owes \$1,414.62.

If you have any questions, please feel free to contact me. These payments should be made to UPRC Litigation, and upon receipt of such, I will send payment to the parties involved.


Patty Schuler gave her report on the function of the Carbon Building.
