A public hearing was held on Case File 97-12 for William R. "Bill" Saulcy and William R. "Rick" Saulcy to rezone from RAM (Ranch-Agriculture-Mining) to RD-40 (one residence for 40 acres). On the recommendation of the Planning Commission, a motion was made by Fleming, seconded by Graalman and unanimously carried to table this public hearing.

On Case File 97-14, Lewis F. Stolns, a motion was made by Graalman, seconded by Fleming and unanimously carried to rezone from RAM (Ranch-Agriculture-Mining) to RD-5 (one residence per 5 acres).

Henry Hewitt updated the Commissioners on the Land Use public meeting dates which are scheduled for the 6th, 7th, 13th and 14th of January 1998 and also on the E.D.C. staff.

ROAD & BRIDGE


Bill Nation gave his administrative report.
