## RESOLUTION 1997 - 2

A RESOLUTION SUPPORTING A LAWSUIT BROUGHT BY THE COUNTIES, AS PLAINTIFFS, ATTACKING THE CONSTITUTIONALITY OF THE NEWLY ENACTED PROPERTY TAX REFUND STATUTE, W.S. §39-3-401, WHICH REDUCES AVAILABLE COUNTY FUNDING.

WHEREAS, The Wyoming County Commissioners Association has previously resolved to support a lawsuit brought by the counties, as plaintiffs, attacking the constitutionality of the newly enacted Property Tax Refund Statute, W.S. §39-3-401, which statute reduces available County funding; and

WHEREAS, litigation joined by all Wyoming counties for this purpose is desirable to show unity of purpose, and significant economies of scale and convenience will be recognized and realized by the counties through consolidation and unification of their efforts in such litigation; and

WHEREAS, Goshen County has offered to take the lead role in the litigation and it is apparent from the nature of the proposed litigation that various costs will be incurred during the pendency of the litigation, as to which CARBON County recognizes its responsibility to undertake to pay its equitable and proportionate share thereof as a potential beneficiary of such litigation; and

WHEREAS, Goshen County reasonable believes that the cost of the proposed litigation will not exceed two hundred dollars (\$200.00) per county;

BE IT THEREFORE RESOLVED, that CARBON County agrees that it is appropriate to join the proposed litigation as a plaintiff, with the understanding that Goshen County is willing to take the lead role as plaintiffs' counsel; and

BE IT FURTHER RESOLVED that CARBON County agrees to pay up to two hundred dollars (\$200.00) as its share of expenses necessarily incurred in the afore-mentioned, proposed litigation.

Case #96-07 - Linda Fleming made a motion, seconded by Gary Graalman and unanimously approved to rezone from Ranching-Agriculture-Mining to Residential, the Battle Lake Townsite, Portion of Block 7, Near State Highway 70, Portion of NE $\frac{1}{4}$  NW $\frac{1}{4}$  Section 29, T14N, R85W with stipulations by the Carbon County Department of Planning and Development.

Case #97-01 --A motion was made by Gary Graalman, seconded by Linda Fleming and unanimously approved to the change of zone from RAM to RD, 5.22 acres, Lot 30, Sierra Madre Subdivision.
