CONSTITUTIONAL AMENDMENTS

PROPOSED CONSTITUTIONAL AMENDMENT A: The adoption of this amendment will allow the legislature to reapportion its membership at the first session after all the census data is available.

PROPOSED CONSTITUTIONAL AMENDMENT B: The passage of this amendment would change the minimum requirement for petition signatures for initiatives and referendums. Currently the petition must be signed by at least fifteen percent (15%) of the qualified voters in the state, with that number based on those who voted in the last general election. There must also be at least one (1) qualified voter signing from at least two-thirds (2/3) of the counties. This amendment would keep the overall, or statewide, number of signatures required the same, but would increase the minimum number required in at least two thirds (2/3) of the counties from one (1) signature, to fifteen percent (15%) of the qualified voters of that county, as determined by the number of votes in the last general election. The purpose of this amendment is to ensure that the signatures needed to place an initiative or referendum on the ballot cannot be gathered in only the most populated counties, and that a significant number of qualified voters from throughout the state support the proposal.

PROPOSED CONSTITUTIONAL AMENDMENT C: The adoption of this amendment would provide that funds paid into the worker's compensation fund may only be expended as provided in the Workers' Compensation Act and for debt service and for workplace safety as provided by law.

CAMPAIGN REPORTING REQUIREMENTS, 22-25-106 (a), W.S. 1977 – ALL candidates whether successful or not shall file a fully itemized statement of receipts and expenditures within ten (10) days after any primary, general, or special election. This is to be filed with the County Clerk by November 13, 1998.

A candidate who fails to file a full and complete statement of receipts and expenditures in the time required, shall receive a notice by certified mail return receipt requested stating that failure to file within three (3) days of receipt shall result in a vacancy in office and may be charged with a criminal offense. A late filing fee of twenty-five (\$25.00) shall accompany all late reports.

If you require assistance to vote by reason of blindness, disability, or inability to read or write, you may be given assistance by a person of your choice. Also, if you have any questions regarding the accessibility of your polling place, please contact the County Clerk.
