**NORTHSIDE CONCERNED CITIZENS**

A group of Baggs area citizens representing Northside Concerned Citizens presented audio and visual exhibits as proof of Elkhead Venture contradictory statements made to area residents during public meetings regarding the milling business to be located north of Baggs. Chairman Zeiger said he would exert what influence he could through written correspondence to aid the Northside Concerned Citizens group.

The Commissioners agreed to send a letter to the Wyoming Department of Environmental Quality (DEQ) expressing concerns of reclamation and/or bonding requirements. The Commissioners indicated they had discussed the bonding and building permit with Carbon County Planner Jonathan Schnal.

Dale Willie, a member of the Northside Concerned Citizens, requested his concerns regarding county road use by Elkhead Ventures be addressed. County Road and Bridge Supervisor Bill Nation told Willie he would review the findings of the Road & Bridge Department in detail with Willie following adjournment of the meeting. Willie agreed to stay after the meeting to hear Bill Nation's report.

**SENIOR CENTERS**

Carbon County Senior Citizens, Inc., director, John Peery requested the exterior of the Baggs Senior Center be stained, and that uneven cement sidewalk slabs be removed from the front of the Baggs Senior Center. The Commissioners agreed to have the exterior stained before winter, weather permitting, and Bill Nation agreed to have Carbon County Road & Bridge crews remove the cement slabs.

**LITTLE SNAKE RIVER HIGH SCHOOL STUDENTS**

A group of students from the Little Snake River High School attended the Commissioner meeting to observe county government in action.

**ROAD & BRIDGE**

Carbon County Road & Bridge department supervisor, Bill Nation presented an administrative report covering the following projects:

Crews continue bus route and hunting/firewood road repairs and grading, including the Dad/Wamsutter and part of the Wild Cow Road.

The screen-all has been moved off Brown's Hill pit to the Willie Pit and will start up there in November with the agreement to leave as much product as is taken.

The underground fuel storage tanks located at the Rawlins shop will be removed November 23, 1998 and an above ground fuel storage system will be installed.

The Commissioners authorized the purchase of a \$1,046.00 sixteen-foot cattle guard for County Road #660 (French Creek Road).

A motion was made by Fleming, seconded by Graalman, and unanimously carried to accept the bid of Ventling Construction in the amount of \$1,425.00 to build a concrete above ground fuel containment structure in the Rawlins yard as approved by the State Fire Marshall. Other bids received were as follows: L.M. Olson \$4,400.00 and Gale Construction \$1,850.00.

**NORTH HANNA ROAD PROJECT**

The Commissioners signed a startup agreement with Wyoming Department of Transportation to allow \$18,432.02 in SC funds to be used for preliminary engineering on the North Hanna Road Project.
