**SEMINOE ROAD**

Andy Long of the Wyoming Department of Transportation reported \$5,130,000.00 from the Public Land Highway program for scenic byways is available for Carbon County to upgrade Seminole Road. Long proposed the funds be used to upgrade the Seminole Road from the Town of Sinclair to the south end of the dug-way road project, and from the north end of the dug-way road project toward Seminole Reservoir as many miles as the funding allows. The Commissioners directed contract engineer PMPC to draft a letter of interest in the proposal from the Carbon County Board of Commissioners to the Wyoming Department of Transportation (D.O.T.). Upon receipt of the Commissioner's letter, D.O.T. will draft an agreement for use of the funds.

**ROAD & BRIDGE**

County Road & Bridge supervisor, Bill Nation reported the following:

Throughout the county, crews continue blading mainly bus routes, and installing culverts and cattle guards.

The screen is in place at Baggs and will be running there through next week.

A loader has been moved to Walcott to haul roto-mill to County Road #500, Jack Creek and County Road #291, Hanna/Leo.

Next week crews will be hauling to County Road #701, Dad-Wamsutter from the Creston D.O.T. pit.

Nation reported a request was received from landowners to move a portion of County Road #602, Brown's Hill. The request was taken under advisement.

PUBLIC HEALTH


The commissioners signed a statement concerning cash handling policies used by the Carbon County Public Health office.
