**SIMONSEN, MADER, TSCHACHER & COMPANY**

Dennis Tschacher from Simonsen, Mader, Tschacher & Company gave his report on the final audit. Mr. Tschacher answered questions from the Commissioners about the report. He gave the County an over all good rating on the audit. A few little details he would like to see taken care of were presented in a separate letter from the audit. The details were not major problems so the County would not be written up on them.

Mr. Tschacher is going to send a disc to be loaded onto our PCs to see if they are in compliance with the year 2000. It is free of charge and can be copied for all offices to use. It will give us time to be able to bring the systems up to date.

Mr. Tschacher requested permission to send out the audit report to the proper agencies to be placed on file. A motion was made by Gary Graalman, seconded by Linda Fleming and unanimously carried to give Mr. Tschacher permission to send out the accepted audit report.

**RAWLINS CARBON COUNTY LIBRARY**

Vicki Hitchcock from the Rawlins Carbon County Library asked the Commissioners how they wanted to proceed with the carpet that was approved last year for the Children's room in the Library. She is trying to get the carpet done at the same time as the other work that is scheduled in the Library. The Commissioners looked over the three bids that were received and suggested the area be remeasured and rebid in a sealed envelope to be delivered to Patty Schuler at the Road & Bridge Department.

Vicki also brought to the attention of the Commissioners that the Drivers License Department would like to be able to use a room in the Baggs Library every other month for the people of Baggs. The Drivers License Department would be responsible for adding the phone line they would need to conduct their business. On the question of rent, the Commissioners wanted to check with Wade Waldrip. The Commissioners approved the Drivers License Department using the Baggs Library.

**CARBON BUILDING**

Dave Day presented an update on the elevator in the Carbon Building. Reconstruction will start on Wednesday, December 23, 1998 with completion expected in about six weeks.

**CARBON COUNTY ROAD & BRIDGE DEPARTMENT**

Road & Bridge Supervisor, Bill Nation, gave his administrative report.

Bill Nation reported on the following projects:

Hauling of roto mill mix continues from the Walcott pit to Carbon County Roads 500 and 291, as well as some of that areas shop driveways and lots.

The two (2) underground tanks that were located north of the Carbon Building have been removed and decommissioned.

The conversion to above ground fueling at the main shop is nearly completed with the electrical hookups this past Friday. Fencing was finished today. The fill decking and gravel will be finished up this week. The State Fire Marshall will do the final inspection next week.

Two (2) of the three (3) pickups that were ordered are in and are available anytime.

Bill requested that all comments concerning county roads be submitted in writing with signatures in order to be considered for future needs. Bill reported that Bart Evans is nearly finished compiling and sizing a more detailed and accurate map for future considerations.

**JEFFREY CENTER**

Ann Taylor, representing the Jeffrey Center, discussed problems with the Jeffrey Center parking lot. After some discussion, the Commissioners decided that the Jeffrey Center Board needs to handle the problem and inform the Commissioners how to proceed to correct the problem. The County will comply with their decision.

**HEALTH INSURANCE**

Gary Graalman talked to Brent Hillier about other organizations such as KIDS being allowed on our insurance program. Mr. Hillier has some concerns about the matter so after some discussion, the Commissioners decided they would like to meet with him further. Gary Graalman will contact Mr. Hillier about meeting with the Commissioners on February 2, 1999 at their regular meeting.


**PLANNING**

Jonathan Schnal, Planning & Economic Director gave a report on the subdivision laws not passing at the State level.


Discussion was also held on the proposed Events Center as far as what the next steps are in the process.
