SHERIFF

Under Sheriff Ernie Hicks presented sealed bids for two vehicles to be used by the Sheriff's department. Following the bid opening, all bid proposals were taken under advisement until specifications could be checked by the Sheriff's office. Bids were received from Fremont Motors, Greiner Motors, McGee-Murphy Ford, and Skyline Motors.

PUBLIC HEALTH

Bridgett Hettigar, director of Carbon County Public Health Nursing Services, presented an administrative report.

WYOMING DEPARTMENT OF TRANSPORTATION

January 6, 1998

Andy Long, P.E., Resident Engineer, Wyoming Department of Transportation (WYDOT), Rawlins, updated the Commissioners on the Seminoe Road project.

A motion was made by Graalman, seconded by Fleming, and unanimously carried to agree to execute an agreement between WYDOT, Carbon County Board of Commissioners and PMPC Consulting Engineer for consulting services on the Seminoe Dam Road Phase 2 project (SC-CFM 6-54).

ROAD & BRIDGE

Bill Nation, Carbon County Road & Bridge Supervisor, presented an administrative report.

ENCAMPMENT WATER SYSTEM

Paul McCarthy of PMPC Consulting Engineers, requested on behalf of the Town of Encampment, the Commissioner's support in applying for funding to improve the town's water system.

A motion was made by Fleming, seconded by Graalman and carried to execute a letter of support for the Town of Encampment.

PLANNING

Henry Hewitt of the Carbon County Planning Commission, and Jim Pedersen, Planning Director presented an administrative report.

PUBLIC HEARING

A public hearing was held for the purpose of considering zone changes.

Case File 97-15, Robert Needhamer

Rezone from RAM (Ranch-Agriculture-Mining) to RD-2 (one dwelling allowed per 2 acres). A motion was made by Fleming, seconded by Graalman, and unanimously carried to approve Case File 97-15.

Case File 97-12, William R. "Bill" Saulcy and William R. "Rick" Saulcy. Rezone from RAM (Ranch-Agriculture-Mining) to RD-40 (one dwelling allowed per 40 acres). A motion was made by Graalman to conditionally approve Case File 97-12 with a formal agreement of understanding to follow. The motion died for lack of a second. A motion was made by Fleming, seconded by Zeiger and carried to table Case File 97-12 until next month (February 3, 1998) at which time the Commissioners will be presented with an executable stipulation agreement between Saulcys and the Carbon County Board of Commissioners.

SHERIFF

Undersheriff Ernie Hicks reported on the checking of specifications in bids opened earlier in the day for two vehicles.

A motion was made by Graalman, seconded by Fleming, and unanimously carried to accept the \$22,007 bid of McGee-Murphy Inc. for one 1998 utility vehicle.

A motion was made by Fleming, seconded by Graalman, and unanimously carried to execute an agreement between Carbon County Commissioners and USDA Forest Service for patrol of areas within the Medicine Bow-Routt National Forest by the Carbon County Sheriff for the period beginning October 1, 1997 and ending September 30, 1998.


LIBRARY


ADJOURNMENT
