**FINANCIAL REPORT**

A monthly financial report from the County Planning office was approved by the Board.

**DELINE ROAD ISSUE**

A motion was made by Graalman, seconded by Fleming, and unanimously carried to adopt an order replacing the hearing officer for the Deline private road issue. Eric Easton, Natrona County Attorney is the newly appointed hearing officer.

**BUREAU OF LAND MANAGEMENT**

A motion was made by Fleming, seconded by Graalman, and unanimously carried to accept the memorandum of understanding between the U.S. Department of the Interior Bureau of Land Management, Wyoming and Carbon County, Wyoming.

Bureau of Land Management representatives, Kurt Kotter, Rawlins District Manager, and Karla Swanson, Great Divide Resource Area Manager reported on various activities and plans for the Carbon County area.

**COOPERATIVE EXTENSION SERVICE**

Doug Reynolds and Ruth Wilson, Carbon County Extension Agents, and Edna McBreen and Steven Aagard, representing the Wyoming Cooperative Extension Service met with the Commissioners to discuss the 4-H Agent position in Carbon County. The Commissioners requested a full time 4-H agent for Carbon County.

**SEMINOE DAM ROAD**

May 5, 1998

Andy Long, Resident Engineer for the Wyoming Department of Transportation updated the Board on negotiations with Domson, Inc., contractor for the Seminoe Dam Road project.

A motion was made by Fleming, seconded by Graalman, and unanimously carried to accept extra work order #5 which supersedes previous work order #5 (original amount \$202,590.00, new amount \$127,127.92).

#### **COMPUTER UPGRADE**

Treasurer Cindy Baldwin, Assessor Darrell Stubbs, and Deputy Clerk Teddy Yockey met with the Commissioners to request the release of \$30,000 for upgrade of the County's computer system.

A motion was made by Fleming, seconded by Graalman, and unanimously carried to commit up to \$20,000 for hardware to change over the computer system.

#### **PLANNING**

Planner Jonathan Schnal reported on the Planning Commission meeting held May 5th at 10:00 a.m. in the Carbon Building.

A public hearing was held for Case File 98-04, AT&T Corp. (a request for variance to allow an addition to an existing battery room to encroach ten feet into a required twenty-foot side yard setback).

A motion was made by Fleming, seconded by Graalman, and carried to follow the recommendation of the Planning Commission and approve Case File 98-04.

#### **LEAGUE OF WOMEN VOTERS**

Karen Larsen, President of the Carbon County League of Women Voters reported the League will sponsor an informational public meeting to review the revised County Land Use Plan draft.

#### **COUNTY HEALTH OFFICER**

A motion was made by Graalman, seconded by Fleming, and unanimously carried to appoint V. Raja Chandra, M.D., P.C. to a four year term as County Health Officer.

#### **CARBON BUILDING**

Carbon Building Manager Patricia Schuler, reported on the walk through held the morning of May 5th for prospective bidders on proposed roof repairs at the Carbon Building. Bidders present for the required walk through were:

The bid specifications prepared by roofing consultant, Techniscan, and approved by the Commissioners require a built-up roof. The Wyoming roofers only apply single ply roofs and will not bid on the project due for completion September 15th, 1998.

Carbon County Road & Bridge Supervisor, Bill Nation presented his administrative report.
