Aguilar for Tract No. 3 in SW1/4 Section 1, Township 17 North, Range 84 West, 6th PM. The motion carried unanimously.

EMERGENCY MANAGEMENT

Greg Zabel, Emergency Management, presented to the Commissioners for signature a Wyoming Emergency Management Safe Match Usage Authorization, Federal Emergency Management Agency Certification.

BLM PRESENTATION

Kurt Kotter from the BLM was in attendance along with Marilyn Roth, Realty Specialist and Jimmy Webb, Assistant Field Manager for Lands and Resources, to speak on the Cherokee Road issue and Rights of Way.

CHEROKEE TRAIL PETITION

Several landowners in the Cherokee Subdivision were in attendance to address a petition, initiated by Judy Smith, for the Cherokee Trail roadway to come under County jurisdiction.

The Commissioners informed the landowners that they would take the petition under advisement.

BOARD OF EQUALIZATION HEARING
