### **APPROVAL OF MINUTES**

A motion was made by Linda Fleming and seconded by Art Zeiger to approve the minutes of the meeting of October 5, 1999. The motion carried unanimously.

### **MUSEUM BOARD**

George Brox of the Carbon County Museum Board presented a plaque of service to Dorothy Wolfard for her dedicated service to the Board. The Commissioners also extended their congratulations and appreciation.

### **RADIO TECH**

Greg Ryan, radio service contractor for County, reported to the Commissioners that he has been repairing the two-way radio system located at Baker Peak. He also brought a piece of the equipment from that station to demonstrate the damage that can be caused by rodents. Mr. Ryan recommended that, rather than replace the radios, the old equipment should be repaired.

### **CLERK**

Linda Ann Smith, Carbon County Clerk presented bonds and payables for signatures.

A motion was made by Linda Fleming and seconded by Art Zeiger to accept resolution 99-07 as read. The motion carried unanimously.

### **RESOLUTION #99-07**

#### **RESOLUTION SUPPORTING SPECIFIC REVISIONS TO SECTIONS 18-5-301 THROUGH 18-5-306**

WHEREAS, Carbon County continues to experience some population growth and consequent land development; and

WHEREAS, there is a need to provide a certain minimal level of development review to insure the health, safety and welfare of present and future landowners of Carbon County, and,

WHEREAS, the Wyoming State Legislature may be considering a bill in the upcoming session which would provide more local discretion in the review of small land divisions and clarify the requirements for review of all land divisions;

THEREFORE BE IT RESOLVED that Carbon County Board of Commissioners do herein express their need for legislation which will:

- 1) Allow local governing boards flexibility and discretion in applying statutory subdivisions requirements to small subdivisions.
- 2) Require land ownership divisions of thirty-five or more acres to provide access acceptable to the local governing board, and
- 3) Change the definition of "Subdivision" to include any division of and ownership not covered by the statutory exemptions.

BE IT FURTHER RESOLVED that the Carbon County Board of Commissioners support this bill and request that each and all of the State Representatives and State Senators elected in Carbon County make every effort to secure the passage of this bill to provide our county with the tools necessary for the beneficial development of Carbon County.

A motion was made by Linda Fleming and seconded by Art Zeiger to accept Change Order #2 to Carbon Power & Light, for the McFadden Fire Station in the amount of \$2464.04. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Art Zeiger to accept Change Order No. 3 to Shepard Construction, in the amount of \$5572.00 for the McFadden Fire Station. The motion carried unanimously.

#### **ARMORY AQUISITION**

A report from Greg Zabel, Emergency Management Manager, was presented to the Commissioners outlining possible uses for the building should it be deeded to the County, which included a letter of request to Rod Janney, Assistant Adjutant General. It was decided by the Commissioners to table discussion of the matter until the next meeting when Commissioner Meacham was in attendance.

#### **PROPERTY EXCHANGE**

A motion was made by Linda Fleming and seconded by Art Zeiger to approve and sign an agreement and warranty deed between Charles Holland and Carbon County, for the exchange of property located under the Golden Spike for the property known as the Ferris Hotel. The motion carried unanimously.

#### **JOHNSON CONTROLS**

Thomas Chadwick reported on several ongoing projects at libraries and senior centers throughout the county.

#### **MEDICINE BOW CLINIC**

The Board of the Medicine Bow Clinic presented pictures of roof damage to the clinic, which is being repaired.

#### **PETITION FOR COUNTY ROAD**

A petition for private road was presented by Stacey Jarrett of Encampment. However, the Commissioners advised Ms. Jarrett of the process for petition for a county road begins with the County Clerk and is then reviewed by the County Attorney. The petition is currently being reviewed by the County Attorney.

#### **PLANNING & ZONING**

A motion was made by Linda Fleming and seconded by Art Zeiger to accept the letter of credit from the Wyoming Ranch Co. (Cassidy Ranch Co.) in the amount of \$369,000.00 to the Greater Bay Bancorp, which expires October 16, 2009. The motion carried unanimously.

#### **ROAD & BRIDGE**

Gary Steele from PMPC discussed Phase II of the Seminole Road Project. The bid for the project came in well under what was allotted and therefore, they are attempting to have the project extended another 1.5 miles to expend the unused grant funds.

A motion was made by Linda Fleming and seconded by Art Zieger to sign Grant Request No. 3 in the amount of \$384.40 to the Wyoming State Loan and Investment Board. The motion carried unanimously.

Bill Nation presented his bi-monthly report to the Commissioners.

Mr. Nation also informed the Commissioners that he submitted his custom-built Road and Bridge Department truck to the 1999 County Road Advisors "You Show Us" Contest. The submission took first place in the region, and is competing with seven other states at the national level in Rapid City, S.D. October 21 and 22.

Being there no further business, the meeting adjourned at 9:15 p.m.
