PUBLIC INPUT

Artlin Zeiger opened the meeting and asked for public input from those in attendance.

Zoda Ferguson, representing the Hanna Library and the Hanna Town Council thanked the Commissioners for their assistance with the library.

Jerry Ferguson on behalf of the Hanna Lions Club, advised the Commissioners that in exchange for the use of the Library Auditorium, they are willing to do the light cleaning of the auditorium.

ROAD & BRIDGE

Bill Nation, Road & Bridge Supervisor gave the departments administrative report.

He discussed work being done on Road #101. They are building up and putting in culverts on Shirley Basin Road #102.

On pending matters, a motion was made by Lee Meacham, seconded by Linda Fleming and unanimously carried to place the drug policy for the Road & Bridge department on the agenda for discussion. After full discussion, a motion was made by Lee Meacham, seconded by Linda Fleming and unanimously approved that the drug and alcohol-testing firm be changed to Day Reporting Systems of Casper, Inc. and Rawlins. This change would result in substantial savings per individual testing.

Nation asked if outside sources requesting drug and alcohol testing would be handled by the county=s program. The consensus of the Commissioners was that the Road & Bridge department handles only its own testing needs.

PLANNING

Jonathan Schnal, Planning and Economic Development Director reported that there will be two (2) new cases coming before the Planning and Development Commission. One project involves a variance proposing 200 to 250 communication towers to be constructed along Interstate 80. This might have a scenic impact along the corridor. The hearing will be scheduled in April.

CLERK

The Board of County Commissioners approved the cash handling policy for the Carbon County Public Health.

The monthly statement of fees collected for January 1999 was signed and approved.

FAIR BOARD

A motion was made by Linda Fleming, seconded by Lee Meacham and unanimously carried to reappoint Anna Helm to a 5-year term on the Fair Board from 2/01/1999 until 2/01/2004.

DIXON AIRPORT BOARD

A motion was made by Linda Fleming, seconded by Lee Meacham and unanimously carried to reappoint Ray Weber to a 5-year term on the Dixon Airport Board from 1/99 until 1/2004.

AIRPORT BOARD

A motion was made by Linda Fleming, seconded by Lee Meacham and unanimously carried to reappoint John France to 5-year term on the Airport Board from 2/01/99 until 2/01/2004.

MUSEUM BOARD

A resignation letter was received from Brenda York effective February 5, 1999 resigning as Board Member and Secretary/Treasurer of the Museum Board. Her term runs until 7/01/2000.

The Carbon County Clerk will advertise for two (2) positions on the Museum Board.

SENIOR SERVICES BOARD

A resignation letter was also received from Marjorie E. Myers effective May 1, 1999 resigning her position as the Baggs representative for the Carbon County Senior Services Board. Her term runs until 3/04/2001.

The term for the Saratoga representative is up for renewal in March 1999 so there will be two (2) openings on this board. The Carbon County Clerk will advertise for representatives from Baggs and Saratoga to fill these positions.

CUSTODIAN

Carbon County Clerk Linda Ann Smith advised the Commissioners that 24 resumes for the two (2) openings for the custodial positions had been received. The Commissioners have agreed to meet to review all applications and select individuals for interviews at a later date.

CARBON COUNTY FAIR

A motion was made by Linda Fleming, seconded by Lee Meacham and unanimously carried for the Commissioners to contribute \$45.00 to the Carbon County Fair for trophies for Grand Champion Market Steer, Grand Champion Market Hog, and Grand Champion Market Lamb.

ADJOURNMENT

There being no further business, the meeting was adjourned at 8:55 p.m. The next regularly scheduled meeting of the Board of Carbon County Commissioners will be Tuesday, March 2, 1999 at 9:00 a.m. in the Commissioner Meeting Room of the Carbon County Courthouse, Rawlins, Wyoming.
