

BOARD OF CARBON COUNTY COMMISSIONERS
Regular Meeting
Tuesday, June 20, 2000

The regular meeting of the Board of Carbon County Commissioners was held on Tuesday, June 20, 2000 in the Commissioners Room of the Carbon County Courthouse, Rawlins, Wyoming. Present were Commissioners Linda Fleming, Lee Meacham and Chairman Artlin Zeiger; Linda Ann Smith, Carbon County Clerk; and Susan Vasey-Haynes, Deputy County Clerk.

A motion was made by Linda Fleming and seconded by Lee Meacham to amend the motion of March 7, 2000 that read to transfer \$360,000 to account 531-461 be amended. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to amend the previous motion to read that \$195,343.30 be transferred from the SC investment account to the 532 account. The motion carried unanimously.

ARMORY AGREEMENT

Tom Thompson was asked by the Commissioners to contact Rod Jennings at the Adjutant General's Office concerning the liability insurance coverage, clarification on monetary responsibility for repairs and maintenance and the status of the current maintenance position.

MALT BEVERAGE PERMITS

Traditionally, the City of Rawlins has handled malt liquor permits for any function within the city limits. However, the Fairgrounds are under the County jurisdiction. Mr. Thompson will be drafting a resolution taking responsibility for liquor permits for functions on County property or out in the County itself through the County Clerk's Office.

COMMUNITY SERVICES BLOCK GRANT

Bridget Hettgar approached the Commissioners concerning the formation of the tripartite board for the administration of the grant. Sweetwater County declined Carbon County's request for participation in the Sweetwater County tripartite board. The State office has suggested that the County hire a consultant to assist in getting the board together for Carbon County. Gary Maier at the State Office requires a letter from the Commissioners that they agree to hire a consultant.

EXECUTIVE SESSION

A motion was made by Linda Fleming and seconded by Lee Meacham to enter into Executive Session with Linda Smith and Alice Garvin for the purpose of discussing personnel at 11:43 a.m. The motion carried unanimously. A motion was made by Linda Fleming and seconded by Lee Meacham to come out of Executive Session at 12:14 p.m. The motion carried unanimously.

JOHNSON CONTROLS

Johnson Controls approached the Commissioners concerning the status of their yearly contract and updated the Commissioners on projects at the Rawlins Senior Center.

SENIOR CENTERS

Bill Michie introduced Sandy Facer as the new site manager in Rawlins. He then presented his monthly report.

NATIONAL GUARD ARMORY

Tom Thompson made clarification of the Armory contract. The Commissioners will hold the contract in abeyance until 4:15 p.m.

WYOMING DEPARTMENT OF TRANSPORTATION

Jay Gould and Rich Douglas discussed the new County Road Improvement Program being implemented by the State.

ROAD & BRIDGE

Bill Nation presented his bi-monthly report to the Commissioners.

RAWLINS FIRE EXTINGUISHER

Scott Hannum of Rawlins Fire Extinguisher Service presented its proposal for updating the fire protection systems in the County buildings.

EMERGENCY MANAGEMENT/NATIONAL GUARD ARMORY

A motion was made by Lee Meacham and seconded by Art Zeiger to enter into agreement with the Wyoming Adjutant Generals Office for the Rawlins National Guard Armory. Lee Meacham and Art Zeiger aye, Linda Fleming nay. Motion carried.

COUNTY MAINTENANCE CONTRACT

The Commissioners reviewed proposals and expenditures from both Johnson Controls and Long and Associates. Johnson Controls had not submitted an estimate that included the Jeffrey Center or Fire Department buildings and it was the determination of the Commissioners that proposals from Johnson Controls and Long and Associates should be equal.

A motion was made by Lee Meacham and seconded by Linda Fleming to table the decision for contract for maintenance for the County buildings until July 11, 2000.

A motion was made by Lee Meacham and seconded by Linda Fleming to send a letter to Johnson Controls notifying them of the termination of their service agreement. The motion carried unanimously.

A motion was made by Lee Meacham and seconded by Linda Fleming that proposals of service for the County Courthouse, Carbon Building, Jeffrey Center, Baggs Health Care Center, Medicine Bow Health Center, all the senior centers, libraries and the armory for heating and cooling maintenance be submitted by 9 a.m. on July 7, 2000 by Johnson Controls and Long & Associates. The motion carried unanimously.

ADJOURNMENT

Being there no further business, the meeting was adjourned at 5:36 p.m.
