WHEREAS, the Governing Body for Carbon County desires to participate in the FEDERAL MINERAL ROYALTY CAPITAL CONSTRUCTION ACCOUNT GRANT program to assist in financing this project; and

WHEREAS, the Governing Body of Carbon County recognizes the need for the project; and

WHEREAS, the Federal Mineral Royalty Capital Construction Account Grant program requires that certain criteria be met, as described in the State Loan and Investment Board's Rules and Regulations governing the program, and to the best of our knowledge this application meets those criteria; and


PARTIAL FIRE RESTRICTIONS

It was reported by Fire Marshall Dwight France that the partial fire restrictions for Carbon County will be lifted as of 9:00 a.m. on September 6, 2000.


ADJOURNMENT
