#### BUDGET PRESENTATIONS

Budget requests for Clerk's Office, Human Resources, Elections, Assessor's Office, County Attorney and District Court were presented to the Commissioners.

#### EXECUTIVE SESSION

A motion was made by Lee Meacham and seconded by Art Zeiger to move into Executive Session at 11:37 a.m. for the discussion of pending litigation. The motion carried unanimously. A motion was made

by Lee Meacham and seconded by Art Zeiger to move out of Executive Session at 12:09 p.m. The motion carried unanimously.

#### RECESS

Chairman Zeiger called recess at 12:10 p.m. The Commissioners reconvened at 1:40 p.m.

#### CARBON COUNTY PLANNING

Jonathan Schnal informed the Commissioners that the projects that were scheduled for the beginning of the month were continued to the beginning of July so applicants would be able to attend both meetings on the same day.

Jonathan also presented the budget proposal for Planning.

#### BUDGET PRESENTATIONS

Budget proposals for Economic Development Commission, County Fair Board, and County Road & Bridge were presented to the Commissioners.

#### LONG & ASSOCIATES

Dave Kenik of Long and Associates approached the Commissioners concerning the heating and plumbing maintenance contract for the County. A motion was made by Lee Meacham and seconded by Art Zeiger to table any action on Long and Associates to the meeting of June 20, 2000. The motion carried unanimously.

#### COUNTY CLERK – REGULAR BUSINESS

A motion was made by Lee Meacham and seconded by Art Zeiger to allow the Chairman to sign the NW Mountain Region 8260-22 form for the AWOS A. The motion carried unanimously.

A motion was made by Lee Meacham and seconded by Art Zeiger to allow the Chairman to sign bonds for Janice Ward, Rusena Cobb, Jacque Bass and Scott Herold as presented. The motion carried unanimously.

A motion was made by Lee Meacham and seconded by Art Zeiger to authorize the expenditure from grant funds of \$7,934.00 for an archeologist study for Fort Steele. The motion carried unanimously.

A motion was made by Lee Meacham and seconded by Art Zeiger to authorize the Chairman to sign the contract for Special Supplemental Food Program between the Wyoming Department of Health, W.I.C., and Carbon County.

A motion was made by Lee Meacham and seconded by Art Zeiger to accept the bid from Energy Housing to fix the ceilings in the Attorney's office in the amount of \$3485.00. The motion carried unanimously.

A motion was made by Lee Meacham and seconded by Art Zeiger to accept the nomination of magistrates for the Circuit Court of Carbon County, Wyoming as follows: Daniel T. Massey, Catherine MacPherson, David E. Erickson, Edward E. Risha, William M. MacPherson, Margie Meacham, Maria E. Lucero, Barbara J. Casados, James P. Espy, Agnes Stocks, Suzie Cox, and Marian Blumenthal. The motion carried unanimously.

#### SHERIFF'S DEPARTMENT

A motion was made by Lee Meacham and seconded by Art Zeiger to allow the Chairman to sign the contract with the Forest Service for reimbursement for forest patrols. The motion carried unanimously.

#### COUNTY TREASURER

Cindy Baldwin reported that the County acquired a piece of land near Battle Lake by tax deed in 1938. The forest service has requested an easement through the 10 acres of land to put in a road. She informed the Board that the Forest Service would approach them at a later date.

#### TOWN OF SARATOGA

Linda Smith advised the Commissioners that the Town of Saratoga contacted the Assessor's Office recently concerning a date of incorporation for the Town. It was discovered that the formal process to incorporate Saratoga was not completed in 1900 through the Commissioners or the recorder's office. The issue has been presented to the County Attorney for recommendations.

A motion was made by Lee Meacham and seconded by Art Zeiger to accept the Monthly Receipt Statement from Carbon County Planning Department. The motion carried unanimously.

A motion was made by Lee Meacham and seconded by Art Zeiger to write a letter of support for the Town of Medicine Bow for application through the EPA for construction of a Water Treatment Plant. The motion carried unanimously.

#### RECESS

Chairman Zeiger recessed the regular meeting at 5:26 p.m. until 8 a.m., Wednesday, June 14, 2000. The meeting was reconvened at 8:12 a.m. on Wednesday, June 14, 2000.

#### BUDGET PRESENTATIONS

Budget proposals for Sheriff's Department, County Treasurer, County Fire Department, and Public Health.

Bridget Hettgar, Carbon County Public Health Director, approached the Commissioners concerning the management of the Community Services Block Grant and the required tripartite board. She requested that, until the Carbon County tripartite board is established, we be joined with the board in Sweetwater County. This would ensure that CSBG funding would be received for this year, and also give Carbon County time to elect its own tripartite board.

The Commissioners heard budget proposals from the County Museum Board, Jeffrey Center and Emergency Management.

#### RECESS

Chairman Zeiger recessed the meeting for lunch at 11:56 a.m. Chairman Zeiger reconvened the meeting at 1:30 p.m.

#### SENIOR SERVICES

A question was raised as to a line item in the budget for lawn care at the Sr. Center in Rawlins. The Commissioners suggested that the Senior Center Director ascertain if other Senior Centers required lawn care money to assist, in an attempt to make all the centers equal with lawn care funds.

Jerry Michie informed the Commissioners that George Wallaby of Rawlins would be donating a lasting legacy statue for the Carbon Building (formerly the Rawlins High School).

A motion was made by Lee Meacham and seconded by Art Zeiger to allow the 50<sup>th</sup> Reunion Committee (Class of 1950) to place the Lasting Legacy sculpture on the Carbon Building property.


#### BUDGET PRESENTATIONS
