A motion was made by Lee Meacham and seconded by Linda Fleming to accept the Annual Hydraulic Elevator Safety Test Inspection Proposal for the Carbon Building from Kone Elevator and Escalator Service. The motion carried unanimously.

A bond for Susan Munson, Clerk/Treasurer for the Town of Riverside, was approved by the Commissioners.

### MEMORIAL HOSPITAL – MRI

Patsy Carter, Dr. Martin Sundell, Karen Pate and Flo Kostic of MHCC and Bill Michie from the MHCC Board of Directors, brought in plans to purchase a new MRI machine for the Hospital. They have been approached with a deal to purchase the equipment and are asking for \$818,000.00 from the County Commissioners to purchase the machine and \$150,000.00 to renovate the room required. The Commissioners requested that the group investigate lease/purchase options and re-present their proposal at a later date.

Legal Description: Sec. 27, T18N, R84W

A Public Hearing for Case File #01-18 was opened by Chairman Zeiger at 2:11 p.m.

Kermit Brown, attorney for the Silver Sage Ranch, expressed concern by his client of the density of the property and future uses by the new landowners. He requested a covenant limiting the density of the property, rather than an agreement between the landowner and the Planning Commission.

Kurt Kelly remarked on behalf of the proposed landowner, that any zone change would be contingent upon closing of the property.

Bill Waller, attorney for the proposed landowner stated that there were no written objections prior to the Planning hearing of this morning. There is no dispute between the parties, and there is no objection to what the new landowner wishes to do. The new owner wishes to build one residence for herself, one residence for her foreman, and other outbuildings in consideration of livestock operation. The density proposed by the new owner is two residences per 243 acres.

Kermit Brown stated that the Commissioners have the authority to enforce the zoning laws as written by the County. He stated that RRA does not recognize assigning density limitations to property. Mr. Brown objects to no agreement or covenant on the property zone change.

Kurt Kelly stated that the applicant has requested the zone density herself, and has agreed to abide by the motion including zoning density restrictions.

The proposed owner, Patty Lufkin, explained that the closing for the property was to be scheduled for last month, but was postponed. The closing is now set for tomorrow, and may be contingent upon zone change.

A motion was made by Lee Meacham and seconded by Linda Fleming to declare a 15 minute recess at 2:50 p.m. The motion carried unanimously.

The Public Hearing for Case File #01-18 was closed at 2:57 p.m.

A motion was made by Linda Fleming and seconded by Lee Meacham to approve the zone change of Case File #01-18 from OR to RRA with the density of two dwellings per 243 acres. The motion carried unanimously.


**LONG & ASSOCIATES**
