#### CLERK

Commissioner Fleming moved to approve the minutes of October 2, 2001 meeting as presented, seconded by Commissioner Meacham. The motion carried unanimously.

Commissioner Meacham moved to close County offices Monday, December 24, 2001 and Tuesday, December 25, 2001 and re-open December 26, 2001. All County offices will remain open for full business on Monday, December 31, 2001 and will be closed January 1, 2002 for the normal holiday. The motion was seconded by Commissioner Zeiger and carried unanimously.

#### RESOLUTION 2001-09

Commissioner Meacham moved to pass, approve, and adopt the Resolution Amending Resolution 1990-5 to allow re-employment of a retiree and that the resolution be made retroactive to October 2, 2001. Commissioner Zeiger seconded the motion. Commissioner Fleming abstained.

#### **RESOLUTION NO. 2001-09**

#### **A RESOLUTION AMENDING RESOLUTION 1990-5 TO ALLOW THE REEMPLOYMENT OF A RETIREE IN COMPLIANCE WITH WYOMING STATUTES 9-3-415(g)**

WHEREAS, Resolution 1990-5, Section 10 states that "Membership in the County retirement system is compulsory for all eligible employees. . ."; and

WHEREAS, it is the desire of the Carbon County Board of Commissioners to update that portion of Resolution 1990-5, Section 10 to comply with Section 9-3-415(g) of the Wyoming Statutes; and

WHEREAS, Wyoming Statutes 9-3-415 (g) authorizes the reemployment of a retiree and is within the framework of Internal Revenue Service requirements for 401(a) qualified retirement plans.

NOW, THEREFORE, BE IT RESOLVED by the Board of Carbon County Commissioners that Resolution No. 1990-5, Section 10 is hereby amended to read:

Section 10. RETIREMENT. Membership in the County retirement system is compulsory for all eligible employees EXCEPT where reemployment of a retiree is approved and such reemployment procedures comply with Wyoming Statutes 9-3-415(g)(i) (ii) (h) (i) (A) (B) (ii) and (j).

Commissioner Meacham moved to go into executive session at 8:15 p.m. The motion was seconded by Linda Fleming and carried unanimously.


Commissioner Fleming moved to come out of executive session at 8:25 p.m., seconded by Commissioner Meacham. The motion was carried unanimously.

**ADJOURNMENT**


There being no further business, Commissioner Zeiger adjourned the meeting at 8:25 p.m.
