**CLERK**

Commissioner Fleming moved to accept the minutes of the October 16, 2001 meeting. Chairman Zeiger seconded. The motion carried unanimously.

Commissioner Fleming moved to amend the motion from October 2, 2001 minutes which read as follows: ".....and appoint Dennis Criswell to fill the unexpired term of Dan Gallenbeck on the Baggs Solid Waste Disposal District Board." It should read that Dennis Criswell was reappointed to fill a new term on the Baggs Solid Waste Disposal District Board. Chairman Zeiger seconded. The motion carried unanimously.

Chairman Zeiger moved to regretfully accept the resignation of I. W. "Bill" Coffman from the Carbon County Memorial Hospital Board. Commissioner Fleming seconded. The motion carried unanimously.

**BONDS**

A Western Surety Bond (#14405127) from Jerry Johnson of Elk Mountain for Carbon County Predatory Animal Board in the amount of \$5,000 was presented to the Board. Bond approved.

**CLERK**

Commissioner Fleming moved to approve either Option #1 and #2 for the proposed match for the State Land Investment Board. Chairman Zeiger seconded. The motion carried unanimously.

Linda Smith advised the Medicine Bow Library lease would go from \$98 per month to \$98 per month plus utilities, for a total cost of \$245 month for a 24 month lease.

Linda Ann Smith advised that a Warranty Deed was received from Roberta Mae Erickson and Frank Erickson, granting to the Board of County Commissioners the property for the Muddy Gap Fire equipment storage building. It reads as follows:

**BIDS FOR THE NOVEMBER 6, 2001 COMMISSIONERS MEETING**

A motion was made by Commissioner Fleming to accept bids, waiving all formalities that may have been inconsistent with the bid specifications but is the lowest bid meeting the requirements of the department as follows:

- 1. County Extension Service vehicle purchase to Dallin Motors in the amount of \$23,353.00.
- 2. Emergency Management vehicle purchase to Dallin Motors in the amount of \$23,788.00.
- 3. Road & Bridge purchase of two (2) ¾ ton (8800#) 4X4 pick-ups to Greiner Ford in the amount of \$26,604.00 LESS trade-in values. By accepting the 8800# ¾ ton pick-up, it would modify the bid back down to a standard size cab, which was in the bid specifications.
