**CLERK**

Commissioner Fleming moved to accept the minutes of December 4, 2001 as written. Commissioner Lee Meacham seconded. The motion carried unanimously.

Linda Ann Smith, Carbon County Clerk, advised we have received transaction confirmation from the state in regard to the following: SCRF Road Construction, High Savery Dam, and County Investments.

**BONDS**

A bond from Allied Insurance for Theresa Archer for Medicine Bow Rural Health Care District in the amount of \$5,000.00 was approved by the Board of Commissioners and signed by Chairman Zeiger.

**CLERK**

Commissioner Fleming moved to authorize the chair to sign the extension of the agreement with the Department of Environmental Quality to extend the Abandoned Mine Land (AML) Grant to January 19, 2005. Lee Meacham seconded. The motion carried unanimously.

Linda Ann Smith advised she had received a letter from Ken Richardson (Quinn / Richardson / Kucera) for Change Order #3 (briefing area windows in Carbon County Sheriff's Office) that will need replaced. The new amount is \$3,850.00.

Commissioner Meacham moved to accept Change Order #3 from Quinn / Richardson / Kucera P.C. in the amount of \$3,850.00. Linda Fleming seconded. The motion carried unanimously.

Commissioner Fleming moved that the chair be authorized to sign the agreement between Carbon County Public Health and Valley View at Saratoga for Physical Therapy and Home Health Client Services. Lee Meacham seconded. The motion carried unanimously.

Linda Smith advised she had received a letter from the Parco Restoration of Historical Buildings. They are now incorporated and approved as a non-tax exempt foundation. Lindy Schmidt, Bill Vasey and Jim Nolan have been working on this project.

The Clerk advised she had received a letter from the Chicano Studies Program at the University of Wyoming. They have agreed to the stipulations presented by the commissioners and expressed their gratitude for the \$5,000.00 in funding from Carbon County.

The Clerk presented a memo to the county commissioners outlining the timelines for special and general elections in 2002. She advised special elections could be held in May, August and November.

If the Board prefers to go with the May, 2003 election, the Clerk must be notified by March 1. Chairman Zeiger requested to see a copy of a resolution.

The Clerk advised she had received a "notice of a workshop" on Cooperating Agency Status from Joe Evans of Wyoming County Commissioners' Association. He would like a count of people who will be attending the meeting on Thursday, February 21, 2002. The Clerk will gather a count of persons wishing to attend and submit the necessary paperwork by 12/19/01.

#### **ROAD AND BRIDGE**

Bill Nation presented his bi-monthly report to the Board of commissioners.


Commissioner Meacham moved to give Bill Nation authorization to obtain bids to repair Bridge #DNC 6-3 (Johnson). Chairman Zeiger suggested we inform the insurance company of our intentions before obtaining bids. Linda Fleming seconded. The motion carried unanimously.


Commissioner Meacham moved that the chair be authorized to sign the lease agreement (8-02973) for office space in the Carbon Building between A&I General Services Administration and the Board of Carbon County Commissioners for the visually impaired. The amount is \$5,676.90 per year for a two-year contract terminating June 30, 2004. The motion carried unanimously. Bill Nation will provide the County Clerk with a copy of the lease agreement.

The next Board of Carbon County Commissioners' meeting is scheduled for January 8, 2002.

There being no further business, the meeting was adjourned by Chairman Zeiger at 8:20 p.m.
