## FLOOR

Chairman Zeiger opened the floor to discussion and questions from those attending the meeting.

## CLERK

Bids for the Ferris Hotel property in Rawlins were opened before the public. The first bid was received from the Downtown Development Authority in the amount of \$2,000.00. A second bid was received from the Rawlins Elks Lodge in the amount of \$15,000.00.

A motion was made by Linda Fleming and seconded by Lee Meacham to award the bid for the Ferris Hotel property to the Rawlins Elks Lodge #609. The motion carried unanimously.

Proposals were also opened for the K.I.D.S. Inc. property at 201 Mahoney, Rawlins. The first proposal was received from the First Southern Baptist Church to lease the property for \$1.00 per year.

The second bid was received from the Rawlins Mennonite Church. They submitted a bid for purchase in the amount of \$70,000.00.

The third proposal was from Gayla's Daycare to rent the property for \$500.00 per month as-is.

A motion was made by Linda Fleming and seconded by Lee Meacham to table the decision regarding the property at 201 Mahoney until the next regular meeting. The motion carried unanimously.

A motion was made by Lee Meacham and seconded by Linda Fleming to declare as surplus several items as presented by the Public Health Department. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to accept a letter of intent with the audit firm of Mader, Tschacher and Petersen as auditors for the County. The motion carried unanimously.

Linda reported that the bridge tenders house has been lowered back down on to its new foundation and there is funding left over for the kiosk.

A motion was made by Lee Meacham and seconded by Linda Fleming to authorize Chairman Zeiger to sign an agreement with Marlena Shellito to provide daycare services at the Fair Grounds tenders home. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to re- appoint Rob Martin to the Upper Platte River Solid Waste Disposal District for a three-year term. The motion carried unanimously.

A motion was made by Lee Meacham and seconded by Linda Fleming to table a resolution for the proposed Saratoga Community Center as presented by Stacy Crimmins of Saratoga until it has been reviewed by the County Attorney. The motion carried unanimously.

**RYAN PARK FIRE DEPARTMENT**

Homer Beach, Fire Chief, Ryan Park Volunteer Fire Department presented two proposals to the Board for construction of an addition to the Ryan Park fire Station to include a restroom, holding tank and automatic door. The first bid was received from Raymer Construction in the amount of \$45,015.00. The second bid was received from Custom Building in the amount of \$44,615.00.

A motion was made by Linda Fleming and seconded by Lee Meacham to reject the proposals submitted for an addition to the Ryan Park Fire Station on the grounds that both bids were over the projected amounts and that the County procedures for bidding were not followed. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to allow the Ryan Park Fire Department to purchase the two overhead door mechanisms. The motion carried unanimously.

Commissioner Fleming suggested that the proper procedures for bidding out the construction for the addition on the fire building in Ryan Park be followed in the spring of 2003.

**ROAD & BRIDGE**

Bill Nation presented his semi-monthly report to the Commissioners.

A motion was made by Lee Meacham and seconded by Linda Fleming to authorize Chairman Zeiger to sign the contractual agreement between Carbon County and PMPC to extend Phase IV, Seminoe. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to authorize Chairman Zeiger to sign the grant draft request No. 8 for the Hanna Access Road. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to send a letter to the Wyoming Transportation Commission concerning the Phase IV funding for Seminoe dam. The motion carried unanimously.

**ADJOURNMENT**

Being there no further discussion, Chairman Zeiger adjourned the meeting at 8:48 p.m.
