CLERK

Minutes

Commissioner Meacham moved to approve the minutes as presented from the July 14, 2003 Public Hearing. The motion was seconded by Art Zeiger and carried unanimously.

Lee Meacham made a motion and Art Zeiger seconded to approve the minutes from the August 5, 2003 Commissioners Meeting as presented. The motion carried unanimously.

Mill Levy Requests

Lee Meacham moved that the Chairman be authorized to sign Mill Levy Requests for Fiscal Year 2003-2004 for the Savery-Little Snake River Water Conservancy District, Baggs Solid Waste Disposal District, Little Snake River Conservation District and the Reader Cemetery District. Artlin Zeiger seconded and the motion carried unanimously.

Grant Agreements

Commissioner Meacham moved and Art Zeiger seconded that the Chairman be authorized to sign the Grant Agreement between the City of Rawlins, Carbon County, the Rawlins-Carbon County Airport Board and the August 19, 2003

United States of America, acting through the Federal Aviation Administration, in the amount of \$150,000 to rehabilitate runway 10/28 at the Rawlins Municipal Airport; and the Grant Agreement between Carbon County and the United States of America, acting through the Federal Aviation Administration, in the amount of \$150,000 for the Dixon Airport to construct a snow removal building and acquire snow removal equipment. The motion carried unanimously.

Monthly Receipts

Linda Smith reported the monthly receipts for the Clerk's Office totaled \$19,855.75 and Planning and Development reported monthly receipts in the amount of \$625.00.

Planning & Zoning

Commissioner Meacham moved to approve Resolution No. 2003-27, A Resolution of the Board of County Commissioners of Carbon County, Wyoming Approving the Subdivision of Land; and Resolution No. 2003-28, A Resolution of the Board of County Commissioners of Carbon County, Wyoming Approving the Rezoning of Land. The motion was seconded by Chairman Zeiger and carried unanimously.

Resolution No. 2003 - 27

A Resolution of the Board of County Commissioners of Carbon County, Wyoming Approving the Subdivision of Land.

WHEREAS, the Carbon County Planning and Zoning Commission held a public hearing on July 1, 2003, which said hearing was advertised by public notice at least thirty (30) days prior to said hearing; and

WHEREAS, at said public hearing, the Carbon County Planning and Zoning Commission provided the public the opportunity to comment and the Carbon County Planning and Zoning Commission considered any public comments which were made at said hearing; and

WHEREAS, at the conclusion of said public hearing, the Carbon County Planning and Zoning Commission voted to certify in writing its recommendation to the Carbon County Commissioners approving the subdivision of land in accordance with the Subdivision Regulations of Carbon County amended March 1980 Carbon County, Wyoming; and

WHEREAS, the Carbon County Commissioners, after receipt of said certified recommendation for approval of the subdivision of land in Carbon County, advertised by public notice at least 14 days prior to a public hearing to take public input and comments which said hearing occurred on August 5, 2003; and

WHEREAS, at said public hearing, the Carbon County Commissioners provided the opportunity for the public to comment and for the Carbon County Commissioners to consider any comments which were made on the proposed subdivisions; and

WHEREAS, the Carbon County Commissioners in considering the said amendment have also reviewed and considered the Carbon County Land Use Plan of 1998; and

WHEREAS, the Carbon County Commissioners have determined that the proposed subdivisions are in conformity with the Carbon County Land Use Plan of 1998 and otherwise promotes the health, safety and general welfare of the residents of Carbon County; and

WHEREAS, at a regularly scheduled meeting of the Carbon County Commissioners, by majority vote, the Carbon County Commissioners moved to approve the following subdivisions.

(1) Case File #03-18 – Irvine Minor Subdivision: Request for approval of the Irvine Minor Subdivision

Preliminary & Final Plat. This proposed division of land creates a 6.61 acre tract containing the existing Irvine Ranch Home. The property is located ½ mile West of County Road #303. A tract of land in the NE ¼ NW ¼ Section 2, T14N, R84W, 6th P.M., Carbon County, Wyoming.

(2) Case File #03-20 – Overlook Minor Subdivision: Request for approval of the Overlook Minor Subdivision

Preliminary & Final Plat. This proposed division of land creates a 11.05 acre tract for future RRA development. The property is located ½ mile West of Encampment on HWY 70 & ¼ mile North of HWY 70. A tract of land in the NE ¼ SW ¼ of Section 2, T14N, R84W, 6th P.M., Carbon County, Wyoming.

Resolution No. 2003 - 28

A Resolution of the Board of County Commissioners of Carbon County, Wyoming approving the Rezoning of Lands.

WHEREAS, pursuant to Wyo. Stat. §18-5-202(b), the Carbon County Planning and Zoning Commission held a public hearing on July 1, 2003, which said hearing was advertised by public notice at least thirty (30) days prior to said hearing; and

WHEREAS, at said public hearing, the Carbon County Planning and Zoning Commission provided the public the opportunity to comment and the Carbon County Planning and Zoning Commission considered any public comments which were made at said hearing; and

WHEREAS, at the conclusion of said public hearing, the Carbon County Planning and Zoning Commission voted to certify in writing its recommendation to the Carbon County Commissioners to adopt this amendment to the Carbon County Zoning Resolution of 2003 for Carbon County, Wyoming; and

WHEREAS, the Carbon County Commissioners, pursuant to Wyo. Stat. §18-5-202(c) and after receipt of said certified recommendation for approval of this amendment to the Carbon County Zoning Resolution of 2003, advertised by public notice at least 14 days prior to a public hearing to take public input and comments which said hearing occurred on August 5, 2003; and

WHEREAS, at said public hearing, the Carbon County Commissioners provided the opportunity for the public to comment and for the Carbon County Commissioners to consider any comments which were made on the proposed amendments; and

WHEREAS, the Carbon County Commissioners in considering the said amendment have also reviewed and considered the Carbon County Land Use Plan of 1998; and

WHEREAS, the Carbon County Commissioners have determined that the proposed amendment is in conformity with the Carbon County Land Use Plan of 1998 and otherwise promotes the health, safety and general welfare of the residents of Carbon County; and

WHEREAS, at a regularly scheduled meeting of the Carbon County Commissioners, by majority vote, the Carbon County Commissioners moved to approve the following amendment(s) to the Carbon County Zoning Resolution of 2003.

(1) Case File #03-13 – Tim and Judy Horst: Request for a Zone Change from Open Range (OR) to Rural Residential Agriculture (RRA-65 acres). Approximately 3 miles South of Rawlins on HWY 71. Approximately 5 acres West of HWY 71 located in the N ½ NW ¼ Section 31, T21N, R87W, 6th P.M., Carbon County, Wyoming.

(2) Case File #03-14 – Tim and Judy Horst: Request for a Zone Change from Open Range (OR) to Rural Residential Agriculture (RRA-15 acres). Approximately 3 miles South of Rawlins on HWY 71. Approximately 15 acres East of HWY 71 is located in the N ½ NW ¼ Section 31, T21N, R87W, 6th P.M., Carbon County, Wyoming.

(3) Case File #03-15 – E. Lynn and Brenda Updike: Request for a Zone Change from Open Range (OR) to Highway Commercial (C-2). The property is located 1 mile North of Baggs on HWY 789. All of Lot 5, Section 33, T13N, R91W, 6th P.M., Carbon County, Wyoming, East of the Easterly right-of-way of Wyoming Highway 789.

(4) Case File #03-16 – Heirs of M.L. Schmidt: Request for a Zone Change from Open Range (OR) to Forestry Production and Recreation (FPR-77 acres, FPR 20.66 acres, & FPR-11 acres, Respectively). The FPR Zone allows a seasonal recreational dwelling. The properties are located 1.5 miles West of Battle Town site on HWY 70 & then 1.5 miles North. The Cox, Merrill, Cooper, and Berger Lode Mining Claim Survey No. 231 embracing a portion of Section 18, T14N, R85W, and Section 13, T14N, R86W, 6th P.M. Carbon County, Wyoming. Containing 77 acres, more or less. The York Lode Mining Claim Survey No. 232 embracing a portion of Section 18, T14N, R85W, and Section 13, T14N, R86W, 6th P.M., Carbon County, Wyoming. Containing 20.66 acres, more or less. The Fourth of July Lode Claim Survey No. 233 embracing a portion of Sections 12 & 13, T14N, R86W, 6th P.M., Carbon County, Wyoming. Containing 11.5 acres, more or less.

(5) Case File #03-17 – William E. Irvine: Request for a Zone Change from Open Range (OR) to Rural Residential Agriculture (RRA-6.61 acres). This 6.61 acre parcel contains the existing Irvine Ranch Home. The property is located ½ mile West of County Road #303. A tract of land in the NE ¼ NW ¼ Section 2, T14N, R84W, 6th P.M., Carbon County, Wyoming.

(6) Case File #03-19 – William E. Irvine: Request for a Zone Change from Open Range (OR) to Rural Residential Agriculture (RRA-11.05 acres). This is a request to rezone the parcel created by Case File #03-20. The property is located ½ mile West of Encampment on HWY 70 and ¼ mile North of HWY 70. A tract of land in the NE ¼ SW ¼ of Section 2, T14N, R84W, 6th P.M., Carbon County, Wyoming.

(7) Case File #03-21 – Lee and Francelle Robinson: Request for a Zone Change from Open Range (OR) to Rural Residential Agriculture (RRA-44.758 acres). The property is located 1 mile East of Savery. A parcel of land being a portion of the NE ¼ SW ¼ and a portion of the SE ¼ NW ¼ of Section 8, T12N, R89W, of the 6th P.M., Carbon County, Wyoming.

(8) Case File #03-22 – Lee and Francelle Robinson: Request for a Zone Change from Open Range (OR) to Rural Residential Agriculture (RRA-30.502 acres). A home is currently located on this parcel. The property is located 1 mile East of Savery. A parcel of land being a portion of the SE ¼ NW ¼ of Section 8, T12N, R89W of the 6th P.M., Carbon County, Wyoming.

(9) Case File #03-23 – Gary and Janet Chrisp: Request for a Zone Change from Open Range (OR) to Rural Residential Agriculture (RRA-36.98 acres). The property is located approximately 1 mile East of Riverside on HWY 230. SE ¼ SW ¼, Section 32, T15N, R83W, 6th P.M., Carbon County, Wyoming (Approximately 36.98 acres).

Bonds

Commissioner Meacham moved that the bond dated July 15, 2003, for W. John Clark, Treasurer of the Carbon County - Dixon Airport Board, in the amount of \$3,000 be approved as presented. The motion was seconded by Chairman Zeiger and carried unanimously.

911 Surcharge

Commissioner Meacham moved and Chairman Zeiger seconded to approve Resolution No. 2003-29, A Resolution Amending the Imposition of a 911 Emergency Telephone Surcharge Fee. The motion carried unanimously.

RESOLUTION NO. 2003-29

A Resolution Amending the Imposition of a 911 Emergency Telephone Surcharge Fee

WHEREAS, Wyo. Stat. §16-9-101 through §16-9-106, effective July 1, 2003, authorizes the establishment of a 911 emergency reporting system and allows a governing body to impose a 911 emergency tax in an amount not to exceed \$.75 per month on service users within the governing body's jurisdiction to pay those costs directly related to a 911 system; and

WHEREAS, Wyo. Stat. §16-9-101 through §16-9-106, defines a **Service User** as any person within the jurisdiction who is provided local exchange access telephone service, wireless communication access service or other technological device that under normal operation is designed or routinely used to access 911, and defines a **Service Supplier** as any utility, person or entity providing or offering to provide 911 system equipment, database installation, maintenance or local exchange access, wireless communication access or other technological device that under normal operation is designed or routinely used to access 911; and

WHEREAS, the Carbon County commissioners passed a resolution imposing a telephone tax in the amount of seventy-five (.75) on each local exchange access line, per wireless communications access or other technological device that under normal operation is designed or routinely used to access 911, within Carbon County, Wyoming, to become effective as of July 1, 2003; and

WHEREAS, the Carbon County Commissioners wish to amend said resolution to exclude land line phones in the municipal limits of the towns of Hanna, Saratoga and Rawlins.

NOW, THEREFORE, be it resolved that the Carbon County Commissioners hereby impose a 911 emergency telephone tax in the amount of seventy-five cents (.75) per month on each local exchange access line, per wireless communications access or other technological device that under normal operation is designed or routinely used to access 911, within Carbon County, Wyoming, excluding from this tax those land line phones within the municipal limits of the towns of Hanna, Saratoga, and Rawlins, or other land line phones which are being taxed by any other Carbon County Municipality.

IT IS FURTHER RESOLVED that **Service Providers** shall be provided written notice of such 911 tax, that the 911 tax shall be collected at the time charges for telecommunications are collected under the regular billing practice of the service provider; that no 911 tax shall be imposed upon more than one hundred (100) local exchange access lines or their equivalent per customer billing; and that the 911 tax imposed pursuant to

this resolution shall be remitted to the Carbon County Treasurer quarterly. Service suppliers are required to collect such surcharges and remit the amounts quarterly, together with required reporting forms. The service suppliers may deduct and retain one percent (1%) of the surcharge for administrative costs.

JAIL COMMITTEE

Gary Olson and Randy Shinkle, appeared to update the Board on the progress of the new jail construction and the bidding process.

John Milosovich of Voorhis Associates, Inc. presented the Transition Proposal in the amount of \$275,000 for the new jail to assist LM Olson, Inc., contractor at risk, Plan One, and jail staff in construction and transition.

RECESS

The Board recessed to the Museum at 10:55 a.m. and returned from lunch at 2:20 p.m.

PLANNING & ZONING

Chairman Zeiger signed both the Overlook Minor Subdivision Plat, Case File #03-20, and the Irvine Minor Subdivision Plat, Case File #03-18.

EMERGENCY MANAGEMENT

Greg Zabel and Pam Farster appeared to discuss Phase I and II of the Homeland Security Grant. For Phase II of the grant, Carbon County was awarded \$395,027.52, Medicine Bow was awarded \$28,209.71, and the City of Rawlins was awarded \$63,080.68.

Commissioner Meacham moved that the Chairman be authorized to sign the Wyoming Emergency Management Association Soft Match Authorization and Certification. Chairman Zeiger seconded and the motion carried unanimously.

EXECUTIVE SESSION

Commissioner Meacham moved to go into executive session at 2:45 p.m. for personnel issues and litigation. Art Zeiger seconded and the motion carried unanimously.

Lee Meacham moved and Art Zeiger seconded to come out of executive session at 3:05 p.m. The motion carried unanimously.

ROAD & BRIDGE

Bill Nation appeared before the Board to present his bimonthly report.

Commissioner Meacham moved to allow Road & Bridge to advertise for a pickup and a semi tractor to be received in November 2003. Chairman Zeiger seconded and the motion carried unanimously.

Lee Meacham moved to accept the bid and enter into agreement with Rocky Mountain Asphalt to work on the Noyes Clinic parking lot in an amount not to exceed \$3,700. Artlin Zeiger seconded and the motion carried unanimously.
