CLERK**Minutes**

Commissioner Fleming moved and Commissioner Meacham seconded to postpone the approval of the minutes from the September 2, 2003 Commissioners meeting until the October 7, 2003 meeting. The motion carried unanimously.

County Road 648 / Boykin

Commissioner Fleming moved to appoint Daniel Massey as Independent Hearing Officer for the hearing scheduled October 28, 2003 for the County Road 648 / Boykin matter and to authorize the Chairman to sign the Order Appointing Independent Hearing Examiner. The motion was seconded by Commissioner Meacham and carried unanimously.

Monthly Receipts

Linda Smith reported the monthly receipts for the Clerk's Office totaled \$17,645.50 and also reported Road & Bridge monthly receipts in the amount of \$200.00.

Medicine Bow Bank Building

Commissioner Fleming moved and Commissioner Meacham seconded that a warrant for \$2000.00 earnest money be made payable to James A. Santilli upon Tom Thompson's review of the title commitment and approval of the same from the Board for the purchase of the Medicine Bow bank building. The motion carried unanimously.

Medicine Bow Rural Health

Commissioner Fleming moved to rescind the bid of \$4,038.34 awarded to Rawlins Glass on September 2, 2003 to replace the windows at the Medicine Bow Clinic based on the notification from Rawlins Glass that labor was not included in the amount of the bid award. The motion was seconded by Commissioner Meacham and carried unanimously.

Commissioner Fleming moved and Commissioner Meacham seconded to award the bid for replacing the windows at the Medicine Bow Clinic to K & K Discount Siding, Inc. in the amount of \$4,700.00, including installation. The motion carried unanimously.

Fire Department Vehicle Bid

Commissioner Fleming moved and Commissioner Meacham seconded to table the discussion regarding the bid awarded to Cris Criswell on September 2, 2003 for a 1962 Mack truck that was advertised as a 1964 Mack, until Dwight France is available for consultation. The motion carried unanimously.

Planning & Zoning Receipts

Linda Smith reported the monthly receipts for Planning & Zoning totaled \$920.00.

Bonds

A bond was approved for Linda K. James, Treasurer of the Carbon County Visitor's Council, in the amount of \$20,000.00, dated August 15, 2003.

IRS Taxable Benefits

Commissioner Meacham moved and Chairman Zeiger seconded to approve Resolution No. 2003-33, A Resolution Following Internal Revenue Service Guidelines For Carbon County Employees' Taxable Benefits. The motion carried with Chairman Zeiger and Commissioner Meacham voting yes, and Commissioner Fleming voting no.

RESOLUTION NO. 2003 - 33

**A RESOLUTION FOLLOWING INTERNAL REVENUE SERVICE
GUIDELINES FOR CARBON COUNTY EMPLOYEES' TAXABLE BENEFITS**

WHEREAS, the Internal Revenue Service has an Employer's Tax Guide to Fringe Benefits that must be followed; and

WHEREAS, certain Employer's benefits must be considered as part of Employee's gross pay, subject to FICA and Medicare contributions and Federal Withholding taxes; and

WHEREAS, Carbon County is desirous of following all Internal Revenue Service rules and regulations.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF CARBON COUNTY:

1. The personal use of a county owned vehicle is a taxable fringe benefit. Personal use includes the value of commuting to and from work in a county vehicle, even if the vehicle is taken home for the convenience of the employer. Such personal vehicle use is a non-cash taxable fringe benefit. Carbon County will use the applicable special valuation rules to determine the value of personal use, included in gross income of each employee.

Employees' use of Qualified Non-Personal use vehicle can be excluded from the County employee's income. Qualified non-personal use vehicles are defined in IRC Reg. 1.274-5T(k)(2)(i) and (ii)..

Commuting expenses. You cannot deduct the costs of driving a car between your home and your main or regular place of work. These costs are personal commuting expenses.

2. Work clothing provided by the employer is not taxable to the employee if the employee must wear them as a condition of employment and the clothes are not suitable for everyday wear.
3. The Internal Revenue Code provides that the value of employer provided meals and reimbursements for meals are included in employee income, unless there is some provision that allows for their exclusion. If meals are not excludable from income as travel expenses, they may still be excludable if they are provided for the convenience of the employer or qualify as de-minimis benefits or entertainment expenses. For the employer to exclude payments, amounts must be paid under an accountable plan.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, WYOMING:



WHEREAS, Wyoming Statutes §16-4-204(c) states that after July 1, 2000, any fees or charges assessed by a custodian of a public record shall first be authorized by duly enacted or adopted statute, rule, resolution, ordinance, executive order, or other like authority; and

WHEREAS, Carbon County is desirous of providing for the fees or charges to be assessed for the production of public records pursuant to the above-referenced act by resolution;

NOW, THEREFORE, BE IT RESOLVED by the Board of Carbon County Commissioners that the following fee schedule shall apply to copies, printouts, or photographs of public records, unless otherwise prescribed by law:

Payment must be provided in advance.

Photocopy Charges	\$.50 per page for the first 10 pages and \$.25 per page for each additional page. The minimum charge for photocopies is \$3.00
Employee Time	The actual cost for employee time shall be assessed at \$14.00 per hour clerical time and \$24.00 per hour for professional time
Electronic Record	\$25.00 per item electronically provided (i.e., including, but copy charges not limited to: C.D., floppy disc, micro film roll, e-mail)
Employee Time for Electronic Records	\$7.00 minimum fee if under one (1) hour. Over one (1) hour, actual employee time shall be assessed at \$14.00 per hour for clerical time and \$24.00 per hour for professional time.

WHEREAS, Carbon County is desirous of providing for the fees or charges to be assessed for the production of public records pursuant to the above-referenced act by resolution;

NOW, THEREFORE, BE IT RESOLVED by the Board of Carbon County Commissioners that the following fee schedule shall apply to copies, printouts, or photographs of public records, unless otherwise prescribed by law:

Photocopy Charges	\$.50 per page for the first 10 pages and \$.25 per page for each additional page. The minimum charge for photocopies is \$3.00
Employee Time	The actual cost for employee time shall be assessed at \$14.00 per hour clerical time and \$24.00 per hour for professional time
Electronic Record	\$25.00 per item electronically provided (i.e., including, but copy charges not limited to: C.D., floppy disc, micro film roll, e-mail)
Employee Time for Electronic Records	\$7.00 minimum fee if under one (1) hour. Over one (1) hour, actual employee time shall be assessed at \$14.00 per hour for clerical time and \$24.00 per hour for professional time.

Commissioner Fleming moved to sign the one-year lease agreement between the Carbon County Board of Commissioners as lessor, and Project Reach as lessee, for the lease of County property at 350 Whipporwill Drive, Baggs, WY beginning September 15, 2003 for the amount of \$10.00 per year. Commissioner Meacham seconded and the motion carried unanimously.

COALBED METHANE

Mickey Stewart and B.J. Kristiansen of the Coalbed Methane Coalition appeared with presentations on the progress of coalbed methane development in Carbon County.

LONG & ASSOCIATES

Commissioner Fleming moved to authorize Long Building Technologies to act as prime contractor and solicit bids for mechanical and electrical work for the heating and air conditioning work at the Courthouse and bring the project cost back to the County for further consideration. The motion was seconded by Commissioner Meacham and carried unanimously.

Jim Flanagan appeared on behalf of the Seminole Boat Club to present an overview of the Boat Club, it's resources and it's facilities. The Boat Club is requesting assistance from Carbon County to repair or replace the private access road to the Boat Club.

A meeting was scheduled for Sunday, October 5 at 10:00 a.m. at the Seminole Boat Club. Any interested individuals are invited to attend to do a "sidewalk survey" to determine the best course of action to complete their request.

The public meeting was ended and the Chairman called the regular meeting to order at 6:00 p.m.

HOMELAND SECURITY

Commissioner Fleming moved to approve the Chairman sign the Grant Award for U.S. Department of Homeland Security, Office for Domestic Preparedness (ODP) FY2003 State Homeland Security Grant Program (SHSGP) in the amount of \$37,800.00 with an award period of September 16, 2003 to December 31, 2004, naming Greg Zabel as contact person, contingent upon the approval of the county's civil attorney. The motion was seconded by Commissioner Meacham and carried unanimously.


STRATTON VS. REIDY


