CLERK

Minutes

Commissioner Fleming moved to approve the minutes from the October 21, 2003 regular Commissioners' meeting as presented. Commissioner Meacham seconded and the motion carried unanimously.

Property Abandonment

Commissioner Meacham moved that the Sheriff's Office be authorized to dispose of a 17" Gateway computer monitor serial #17014C345518. Commissioner Fleming seconded and the motion carried unanimously.

Dixon Airport Board

Commissioner Fleming moved to authorize the Chairman to sign the Northwest Mountain Region Operations and Maintenance Manual between the Dixon Airport Board and the Service Management Office (SMO), a division of the Federal Aviation Administration. Commissioner Meacham seconded and the motion carried unanimously.

Commissioner Meacham moved to authorize the Chairman to sign two reimbursement requests from the Dixon Airport Board for FAA Project No. 3-56-0038-06 in the amounts of \$800.00 and \$9,000.00. Commissioner Fleming seconded and the motion carried unanimously.

Commissioner Fleming moved and Commissioner Meacham seconded to authorize the Chairman to sign a reimbursement request from the Dixon Airport Board for State Project No. 2242 in the amount of \$21,020.00. The motion carried unanimously.

Capital Facilities Tax Survey

Clerk Smith presented a request and survey from the Wyoming County Commissioners Association. The survey is requesting information for estimated capital facilities needs in the future. The Board asked Clerk Smith to please fill out and submit the survey.

ELECTED OFFICIALS

Cheryl Ross, Deputy Assessor presented two tax rebates and eight tax abatements for approval.

Cindy Baldwin presented a letter from Memorial Hospital of Carbon County requesting the final payment of \$25,974.73 from the capital facilities tax for the new ambulance.

SENIOR SERVICES

Bill Michie presented his monthly report to the Board.

EMERGENCY MANAGEMENT

Greg Zabel and Pam Farster came before the Board to discuss the status of Homeland Security Grant funding and planning. Ms. Farster reported that the County was awarded Phase I funds of \$135,345.12 and Phase II funding of \$297,482.40. She reported that 18 million has been awarded to Wyoming for 2004 with an application deadline of November 30, 2003, and that the Homeland Security work group will be meeting again soon. The group is necessary under the Homeland Security guidelines and representatives from all towns and cities in the county were invited to participate as well as personnel from throughout the county representing law enforcement, emergency medical, fire services, hazardous materials, public works, public health, public safety, health care, weed and pest, agriculture, and county administration to review the priority list for funding allocations. The work group will also participate in preparing a needs assessment for the county which is required in order to receive future funding.

JAIL COMMITTEE

Charlie VanOver appeared along with Gary Olson and Randy Shinkle to present the color scheme proposed for the outside of the new jail building. They also reported on the progress of construction at the site.

SEARCH & RESCUE

Under Sheriff Ernie Hicks presented the search and rescue hours for the current period. The hours totaled 456 to date. Under Sheriff Hicks will turn in the names and hours to the County Clerk's Payroll Department by November 20, 2003 for payment.

LUNCH

Chairman Zeiger adjourned the meeting for lunch at 12:35 p.m. and reconvened at 1:30 p.m.

PLANNING & ZONING

Jay Grabow appeared to recommend a public hearing be held for Case File #03-30 – Judith Geiger.

Commissioner Meacham moved to set a hearing for December 2, 2003 at 2:00 p.m. to hear Case File #03-30, Judith Geiger, a request for a Zone Change from Open Range (OR) to Forestry Production and Recreation. The motion was seconded by Commissioner Fleming and carried unanimously.

CARBON BUILDING

Kandis Peach, Carbon Building Manager, presented bids for new cabinets for the Public Health Office.

Commissioner Fleming moved that the Public Health Office cabinet project bid be awarded to Brown & Sons in the amount of \$2,850.00 The motion was seconded by Commissioner Meacham and carried unanimously.

ROAD & BRIDGE

Bill Nation appeared to present his bi-monthly report to the Board.

COOPERATIVE EXTENSION SERVICE

Warren Crawford of Carbon County Cooperative Extension Service, and Phil Rosenlund, of the University of Wyoming Extension Service, gave an informational presentation on community development projects. The presentation was based on a community owned clothing store already in place in Powell, Wyoming.

PUBLIC HEALTH

Bridget Hettgar reported that \$64,000.00 of Homeland Security money has been allotted for each county for a new full-time position in the Public Health Department dealing with bioterrorism.

The Board advised Ms. Hettgar to discuss this with Pam Farster, who is currently contracted with the County for Homeland Security grant purposes to determine how the County could accept and best use the money.

MECHANICAL BID OPENING

The following mechanical bids for the Courthouse heating/air conditioning project were opened:

Bids were to be received in the County Clerk's Office by October 31, 2003. However, U.S. Mechanical's bid was received in the Clerk's Office Monday, November 3, 2003 by FedEx. The delivery of this bid was delayed due to restricted travel because of the weather.

Commissioner Fleming moved to go into executive session for discussion of litigation at 3:34 p.m. The motion was seconded by Commissioner Meacham and carried unanimously.

Commissioner Meacham moved and Commissioner Fleming seconded to come out of executive session at 4:14 p.m. The motion carried unanimously.


COAL-BED METHANE
