**FIRE TANKER BIDS**

Midwest Fire & Equipment and Repair Company submitted a bid for an FS 2000 gallon tanker/pumper fire vehicle in the amount of \$140,685.00.

Linda Fleming moved to take this bid under advisement and have the county clerk meet with the Fire Department to see if it meets their specifications. Lee Meacham seconded. Linda Fleming amended the motion to include that the

bid be awarded to Midwest Fire & Equipment if it meets with the proper specifications. The motion carried unanimously.

The 2004 Proposed Equipment Expenditures total \$395,565.15. This amount provided mobile radios for all fire and ambulance services in Carbon County; a base unit for Memorial Hospital of Carbon County, a Rawlins base; and Emergency Management base unit, mobile and portable units.

Linda Fleming moved to approve the proposed expenditures for the Homeland Security grant in the amount \$390,499.73 for 2004. Lee Meacham seconded. The motion carried unanimously.

The Commissioners suggested a public meeting be held to give the public an opportunity to listen to information and provide input on this issue.


**TITLE 25 INTERVIEW**
