## CLERK

### Minutes

Commissioner Fleming moved to approve the minutes from the October 5, 2004 Commissioners meeting as presented. Chairman Zeiger seconded and the motion carried unanimously.

### Monthly Receipts

Clerk Smith presented Circuit Court forfeitures in the amount of \$88,035.23 for the month of September and receipts for Planning & Zoning in the amount of \$430.00.

### Capital Facilities Tax

Clerk Smith reported on September 2004 tax and interest on the capital facilities tax. She stated the Treasurer Baldwin wired \$155,065.26 for Carbon County's portion and to date Carbon County has received a total of \$1,293,557.27.

### ROAD & BRIDGE

Bill Nation presented his bi-monthly report.

Commissioner Fleming moved to authorize Road & Bridge to advertise for a new position in the Hanna area due to the retirement of Coy Giradot and to declare a bridge on County Road #752 as surplus, and it be advertised to be sold to the highest bidder. Chairman Zeiger seconded and the motion carried unanimously.

### NOYES CLINIC

Ron Taylor of the Noyes Clinic in Baggs reported on building conditions at the clinic.

Mr. Taylor reported that he has received homeland security funding to purchase one new radio for an ambulance and hopes to receive enough funding to purchase a second radio.

The Noyes Clinic is considering a mutual aid agreement with Moffat County, Colorado designating boundaries that each ambulance service will cover. The Board stated its support for the agreement.

### DIXON AIRPORT

Jim Sirhall of the Airport Development Group in Denver, Colorado reported on the progress of development of the Dixon Airport. Mr. Sirhall reported that in 2002, a plan was devised to rehabilitate the runway that included land acquisition and an environmental assessment.

David Pratt of the Three Forks Ranch stated that he would construct a full-service fixed based operations hanger that would be located on land owned by Three Forks Ranch. This hanger would provide fuel and have maintenance operations. Mr. Pratt stated that Three Forks Ranch would also donate the county's 2% funding match required by the state in return for an extended lease fee. Mr. Pratt offered to donate the 86 acres needed to extend and widen the runway.

Additional land would be required from two other landowners. Mr. Sirhall stated that these landowners would have an easement allowing them to use the land as they are currently, and that no structures will be built on the land.

The Airport Development Group will revise the airport plan and present it to each affected landowner and the Board at a future date.

### Grant Application

Commissioner Fleming moved to authorize the Chairman to sign the Request for State Airport Aid in the amount of \$150,000.00 for engineering and supervision of runway rehabilitation at the Dixon Airport. Chairman Zeiger seconded and the motion carried unanimously.

Commissioner Fleming moved to authorize the Chairman to sign the Dixon Airport Land Acquisition Grant Invoice No. DIX1059L-0409-001, Project No. 3-56-0038-07 in the amount of \$17,572.99. Chairman Zeiger seconded and the motion carried unanimously.

Commissioner Fleming moved to authorize payment to the Airport Development Group in the amount of \$2,500.00 and Forrest Line Construction in the amount of \$33,625.80 to construct a snow removal equipment storage building at the Dixon Airport. Chairman Zeiger seconded and the motion carried unanimously.

Commissioner Fleming moved to authorize the Chairman to sign the Request for Payment of State Funds for Airport Construction, Planning or Improvements at the Dixon Airport, Project No. 3-56-0038-06 in the amount of \$2,890.00; and to authorize the Chairman to sign the Outlay Report and Request for Reimbursement for Construction Programs in the amount \$32,513.00 for the Federal share. Chairman Zeiger seconded and the motion carried unanimously.

Commissioner Fleming moved to pay the appraiser the amount of \$10,000.00 for services at the Dixon Airport. Chairman Zeiger seconded and the motion carried unanimously.

**ADJOURNMENT**

There being no further business, Chairman Zeiger adjourned the meeting at 9:16 p.m.
