CLERK

Payroll Publication

The Board authorized the Clerk to publish the Carbon County Employee Payroll Publication in both the Daily Times and Saratoga Sun as required by Wyoming State Statute.

Cooperative Extension Service

Commissioner Meacham moved to authorize the Chairman to sign the Extended Professional Service Agreement between the University of Wyoming and the Board of County Commissioners of Carbon County in the amount of \$9,381.00 to provide half the salary of Extension Office personnel. Commissioner Fleming seconded and the motion carried unanimously.

HIPAA Agreements

Commissioner Meacham moved that the Chairman be authorized to sign the Corporate Benefit Services of America, Inc. Assurance Letter with Carbon County as required to be in compliance with Section 164.502 of the HIPAA privacy policies and procedures permitting disclosure to a Business Associate of a Health Care Plan including Scrip World, LLC, and Intermountain Benefit Administrators. Commissioner Fleming seconded and the motion carried unanimously.

Commissioner Fleming moved that the Chairman be authorized to sign Exhibit G, an Amendment to the Administrative Service Agreement Business Associate Agreement dated originally October 1, 2003, between Carbon County, Corporate Benefit Services of America, Inc., and Intermountain Benefit Administrators, Inc. in order to comply with HIPAA privacy policies and procedures. Commissioner Meacham seconded and the motion carried unanimously.

Board Appointments

Commissioner Meacham moved to reappoint Jewell Allen and Sy Lein to the Senior Services Board each for three-year terms ending April of 2007. Commissioner Fleming seconded and the motion carried unanimously.

Commissioner Fleming moved to reappoint Anna Helm to the Fair Board for a five-year term ending February 2009. Commissioner Meacham seconded and the motion carried unanimously.

Bonds

Commissioner Fleming moved to approve and authorize the Chairman to execute a bond for Lezlee Musgrave, Clerk/Treasurer for the Town of Sinclair in the amount of \$8,000.00. Commissioner Meacham seconded and the motion carried unanimously.

Monthly Receipts

Clerk Smith presented monthly receipts for the Clerk's Office in the amount of \$13,065.25, and Carbon County Planning Department receipts in the amount of \$275.00.

Noyes Health Care Center

Clerk Smith presented a letter from the Noyes Health Care Center requesting that three of their employees be placed on the County's health insurance plan.

Commissioner Fleming moved that Noyes Health Care Center employees be included in the County's health insurance plan and that all costs included with this be paid by the employees and the Center. Commissioner Meacham seconded and the motion carried unanimously.

New Jail Project

Clerk Smith reported that \$8.6 million has been placed in the Community First National Bank's depository account for the new jail project.

PUBLIC HEALTH

Bridget Hettgar requested approval of a bioterrorism/homeland security funding contract for Carbon County so that Public Health can establish an emergency preparedness plan in the County. Ms. Hettgar reported that the state has divided funding between Counties to hire an all-hazardous response coordinator. This is a funded position until June 30, 2005 and would be under the supervision of the Public Health Department.

Commissioner Meacham moved to authorize the Chairman to sign the Contract between the Wyoming Department of Health, Community and Family Health, Public Health Nursing, and Carbon County for Public Health Emergency Preparedness. Commissioner Fleming seconded and the motion carried unanimously.

WEST NILE VIRUS

Zola Ryan of the Carbon County Cooperative Extension Service gave a presentation on West Nile Virus. She overviewed statistics for Wyoming and Carbon County and stated how the disease is spread and how individuals may protect themselves.

HOMELAND SECURITY

Pam Farster reported on the Homeland Security grants. She stated that there were two grants awarded to Carbon County in 2003 and these funds are being used to purchase radios, fire service equipment, health equipment, and other security equipment.

COALBED METHANE

Mickey Stewart and B.J. Kristiansen of the Coal Bed Methane Coalition each gave presentations on coal bed methane development, what coal bed methane is, how it is extracted, and how the coalition plans to help gain the most methane with the least disturbance to the surrounding areas.

Ms. Stewart discussed a watershed analysis done by the coalition for a section of Campbell County and recommended that Carbon County develop such an analysis for property owners and developers to use as a communications tool as there is a possibility of some significant coal bed methane development in Carbon County.

Ms. Stewart also reported that an informational coal bed methane meeting is scheduled for March 24, 2004 at the Little Snake River School in Baggs, WY beginning at 7:00 p.m.

ROAD & BRIDGE

Bill Nation presented his bimonthly report. Ron Garretson, the district supervisor for the Saratoga / Encampment area for Road and Bridge was also present.

Mr. Nation was given authorization for the purchase of a new engine for an International end-dump in the amount of \$5,939.55.

ADJOURNMENT

There being no further business, Chairman Zeiger adjourned the meeting at 9:14 p.m.
