### CLERK

#### Minutes

Commissioner Meacham moved to approve the minutes from the September 6, 2005 Commissioners meeting as presented. Chairman Zeiger seconded and the motion carried unanimously.

#### Homeland Security Grant

Commissioner Meacham moved to authorize the Chairman to sign the Grant Award for U.S. Department of Homeland Security (DHS), Office of State and Local Government Coordination and Preparedness (SLGCP), FY2005 Office for Domestic Preparedness (ODP) Homeland Security Grant Program (HSGP), Emergency Management Performance Grant (EMPG) Allocation Part-II, in the amount of \$3,103.00, Project ID 05II-ODP-CAR-EM-HCC5. Chairman Zeiger seconded and the motion carried unanimously.

Commissioner Weickum joined the meeting at 9:05 a.m.

#### Maternal and Child Health

Commissioner Meacham moved to authorize the Chairman to sign the Contract Between the State of Wyoming Department of Health, Community and Family Health Division's Maternal and Child Health (MCH) Section and Carbon County for maternal and child health services for a term of one year ending September 30, 2006. Commissioner Weickum seconded and the motion carried unanimously.

#### Bioterrorism Representative

Commissioner Meacham moved to authorize the Chairman to sign the Renewal Agreement Amendment Number One to Contract Between Wyoming Department of Health, Public Health and Terrorism Preparedness and V. Raja Chandra, M.D., for a period of one year ending August 2006 and amending the original contract amount to \$26,000.00. Commissioner Weickum seconded and the motion carried unanimously.

#### Emergency Services

Chief Deputy Clerk, Diana Obe, presented an agreement between Natrona and Carbon counties for All Hazards Mutual Aid. Ms. Obe stated Tom Thompson has reviewed the agreement and recommended its approval.

Commissioner Weickum moved to authorize the Chairman to sign the All Hazards Mutual Aid Agreement Between the Counties of Natrona and Carbon dated July 20, 2005. Commissioner Weickum seconded and the motion carried unanimously.

#### Monthly Receipts

Ms. Obe presented Road & Bridge monthly receipts in the amount of \$50.00.

#### 4-H Leaders

Ms. Obe presented a list of 4-H leaders and a request for these individuals to be added to the County's liability insurance.

The Board asked for more information on the request and exactly what these individuals want to be covered for and advised Ms. Obe to present the information to Tom Thompson to review.

#### Dixon Airport

Diana Obe presented a Request for State Airport Aid for the Board's consideration and stated Tom Thompson has reviewed the document and recommended its approval.

Commissioner Meacham moved to authorize the Chairman to sign the Request for State Airport Aid in the total amount of \$2,144,836.00 for runway rehabilitation and installation of AWOS at the Dixon Airport. Commissioner Weickum seconded and the motion carried unanimously.

#### Bonds

Commissioner Weickum moved to approve a bond for Joan Page, Treasurer for the Carbon County Museum Board in the amount of \$1,000.00. Commissioner Meacham seconded and the motion carried unanimously.

Commissioner Weickum moved to approve a bond for Ransom Hackett, Treasurer of the Baggs Solid Waste Disposal District in the amount of \$10,000.00. Commissioner Meacham seconded and the motion carried unanimously.

Commissioner Weickum moved to approve a bond for Marilyn Caracena, Treasurer of the Carbon County Library Board in the amount of \$3,000.00. Commissioner Meacham seconded and the motion carried unanimously.

#### Corporate Benefit Services of America

Diana Obe reported that Corporate Benefit Services of America has been informed by the Department of Labor they must separate accounts for all covered entities. Ms. Obe stated this will affect the Treasurer's Office as they balance this account and she has notified Cindy Baldwin of the change.

#### GIS / GPS

Karen Larsen updated the Board on the progress of rural addressing. Ms. Larsen reported she is currently assigning addresses between Walcott and Encampment.

#### SPECIAL DISTRICT BUDGET SUMMARIES

Commissioner Weickum moved to approve the Final Budget Summaries for the Reader Cemetery District in the amount of \$16,179.00; Little Snake River Conservation District in the amount of \$504,115.00; Savery-Little Snake River Water Conservancy District in the amount of \$10,883.00; and the Baggs Solid Waste Disposal District in the amount of \$882,380.00; and to notify each District of the deadline to submit their budget summaries. Commissioner Meacham seconded and the motion carried unanimously.

#### HOMELAND SECURITY

Pam Farster updated the Board on Homeland Security expenditures and balances. Ms. Farster requested and received authorization for various equipment purchases. Ms. Farster also presented a listing of fire grants received around the state, noting several in Carbon County.

#### CARBON BUILDING

Kandis Fritz, Carbon Building Manager, presented one sealed bid for mold abatement and related repairs at the Carbon Building. The bid was from Energy Construction in the total amount of \$28,390.00 to remove, dispose of, and replace sheetrock, paneling, and carpeting. The bid states that, if accepted, work would begin December 2005 or January 2006.

Ms. Fritz stated that we received \$23,390.00 from the county's insurance company for these repairs.

Commissioner Meacham moved to accept the bid from Energy Construction in the amount of \$28,390.00 dated August 30, 2005 for mitigation work for mold at the Carbon Building. Commissioner Weickum seconded and the motion carried unanimously.

Ms. Fritz stated part of the work to be done is in the county records room that is maintained by the Clerk's Office. She requested that County Clerk, Linda Smith, have all records and shelving removed from the area when needed.

#### ROAD & BRIDGE

Bill Nation reported that on September 7, a fire started from a lightning strike south of Rawlins. Mr. Nation reported he was able to assist in containing the fire with the fire-fighting dozer recently purchased.

**Area Work**

Mr. Nation reported that plugged culverts in various areas of the county are being worked on and county roads are being bladed as requested and along school bus routes.

**EXECUTIVE SESSION**

Commissioner Meacham moved to go into executive session at 11:50 a.m. with Diana Obe, Mike Morris, Randy Shinkle, and Tom Thompson to discuss potential litigation. Commissioner Meacham seconded and the motion carried unanimously.

Gary Olson and Charlie VanOver joined the executive session at 12:05 p.m.

Gary Olson and Charlie VanOver left the executive session at 12:50 p.m.

Commissioner Meacham moved to come out of executive session at 1:08 p.m. Commissioner Weickum seconded and the motion carried unanimously.

Chairman Zeiger stated that no action was taken during executive session.

**TELECOMMUNICATIONS SYSTEM**

Commissioner Meacham moved to authorize the Clerk's Office to once more survey county offices for any remaining items or issues that need attention and convey the results to Tom Herdt of Capitol Communications. Commissioner Weickum seconded and the motion carried unanimously.

**LM OLSON RETAINAGE**

Commissioner Weickum moved to release one half of the retention held on the new jail project to LM Olson Construction as soon as it can be arranged, subject to approval of the Carbon County Detention Facility Joint Powers Board. Commissioner Meacham seconded and the motion carried unanimously.

The Board requested the Joint Powers Board be contacted by phone to take each member's vote on releasing the retention funds and to contact the Treasurer's Office to arrange the transfer of these funds.

**EXECUTIVE SESSION**

Commissioner Weickum moved to go into executive session at 1:14 p.m. with Tom Thompson and Diana Obe to discuss personnel. Commissioner Meacham seconded and the motion carried unanimously.

Commissioner Meacham moved to come out of executive session at 2:00 p.m. Commissioner Weickum seconded and the motion carried unanimously.

Chairman Zeiger stated that no action was taken during executive session.


**ADJOURNMENT**
