## CLERK

### Minutes

Commissioner Weickum moved to approve the minutes from the May 17, 2005 Commissioners meeting as presented. Commissioner Meacham seconded and the motion carried unanimously.

### Bonds

Commissioner Meacham moved to approve bonds for Courtney Bohlender, Treasurer for the Town of Saratoga in the amount of \$10,000.00; Lee Meacham, County Commissioner in the amount of \$1,000.00; Lindy L. Schmidt, District Court Clerk in the amount of \$10,000.00; Darrell L. Stubbs, County Assessor in the amount of \$5,000.00; Jerry Colson, County Sheriff in the amount of \$4,000.00; and Patty Waldron, Secretary/Treasurer for the Reader Cemetery District of Carbon County in the amount of \$4,000.00. Commissioner Weickum seconded and the motion carried unanimously.

### Monthly Receipts

Monthly receipts were approved for the Clerk's Office in the amount of \$17,354.00 and Road & Bridge in the amount of \$150.00.

### Courthouse Heating/Cooling Project

Commissioner Meacham moved to forward U.S. Mechanical Payment Application No. 7 in the amount of \$81,000.00 to the Bank of the West to be paid from the lease/purchase funds in reference to the Courthouse heating and cooling project. Commissioner Weickum seconded and the motion carried unanimously.

### Project Prevention

Clerk Smith stated that Tom Thompson has reviewed the Substance Abuse Division Community Block Grant Application in the amount of \$6,000.00 for Project Prevention.

Commissioner Weickum moved to approve the contract between the Wyoming Department of Health Substance Abuse Division and Carbon County Commissioners in the amount of \$6,000.00 to be used by Project Prevention. Commissioner Meacham seconded and the motion carried unanimously.

### Jail / LM Olson Payment Application

Commissioner Weickum moved to accept LM Olson's Payment Application No. 23 in the total amount of \$94,304.48 paying \$83,814.13 to LM Olson and \$10,490.35 paid to LM Olson's escrow account and authorized the application be forwarded to the Carbon County Detention Facility Joint Powers Board for payment. Commissioner Meacham seconded and the motion carried unanimously.

### Fireworks Displays

Clerk Smith stated that County Fire Warden, Dwight France, has reviewed and approved two requests for fireworks displays to be held in July 2005.

Commissioner Meacham moved to authorize the Flying Diamond Ranch and the Baggs Fire & Rescue to hold fireworks displays as stated in each request in July 2005. Commissioner Weickum seconded and the motion carried unanimously.

### Fiber Optics Feasibility Study / CDBG

Clerk Smith reported she has prepared a plan of action for the feasibility study for the proposed fiber optics project in Carbon County. She is asking for five team members to assist in interviewing and a scope of work review. She has included a representative as a team member from each entity that will be contributing matching funds and requested one of the Commissioners be an interviewer. The Board stated it will consider her request later in the meeting.

### New Jail

Clerk Smith stated that she has researched the issue of the substantial completion date of the new jail. The Carbon County Detention Facility Joint Powers Board has requested the Commissioners reply stating the substantial completion date and what penalties apply if the contractor fails to meet that date.

Tom Thompson stated he has reviewed the contract and feels the Joint Powers Board was formed to handle the financing portion of the new jail and that any contractual issues are the responsibilities of the Board of County Commissioners. The Clerk presented a proposed letter to the Joint Powers Board. The Board's consensus was the Clerk could send the letter.

### Law Enforcement Memorandum of Understanding

Commissioner Meacham moved to authorize the Chairman to sign the Memorandum of Understanding Between the Carbon County Sheriff's Office, the Towns of Encampment and Riverside, Wyoming establishing the terms and conditions under which certified peace officers of Encampment may provide law enforcement assistance within the municipal limits of the Town of Riverside, Wyoming. Commissioner Weickum seconded and the motion carried unanimously.

### ELECTED OFFICIALS

#### Assessor

Commissioner Weickum moved to authorize the Chairman to sign the Memorandum of Understanding Between the Wyoming Department of Revenue and Carbon County regarding the new Computer Assisted Mass Appraisal (CAMA) System for the County Assessor's Office. Commissioner Meacham seconded and the motion carried unanimously.

County Assessor Darrell Stubbs presented an Abstract of Assessment Roll for Carbon County, Wyoming for 2005.

#### Clerk of District Court

Clerk of District Court, Lindy Schmidt, presented an amended Cooperative Agreement for child support.

Commissioner Meacham moved to authorize the Chairman to sign Amendment Number One to Cooperative Agreement Between the Wyoming Department of Family Services Child Support Enforcement Unit and the Carbon County Clerk of District Court, adding one year to the original Agreement dated October 14, 2004. Commissioner Weickum seconded and the motion carried unanimously.

#### Treasurer

Treasurer Cindy Baldwin reported that the Wyoming Supreme Court has ruled on the issue of comparable value.

Ms. Baldwin reported that she found three properties owned by the county in Hanna that could possibly be used for a new medical clinic. She stated she forwarded the information to Patsy Carter at the Memorial Hospital of Carbon County for her review.

### SENIOR SERVICES

Teresa Archer presented bids from Hunny-Do Construction and Schroeder Construction LLC to repair the roof and replace the windows at the Encampment Senior Center.

Ms. Archer also reported on various purchases of equipment and requested authorization to purchase a 30-quart mixing bowl to be used at the Rawlins Senior Center in the amount of \$778.57.

The Board authorized Ms. Archer to purchase the bowl and pay the invoice from the current fiscal year's budget. The bids for roof and replacement of windows will be considered at budget meetings.

### EMERGENCY MANAGEMENT

Greg Zabel reported that the National Guard has requested office space at the Armory to use for a part-time recruiter. Mr. Zabel stated his approval for the request. Mr. Zabel also reported on various other armory usage schedules.

The Board authorized Mr. Zabel to allow office space one National Guard recruiter at the Armory.

### HOMELAND SECURITY

Pam Farster presented a letter clarifying how the County Sheriff's Office can expend Homeland Security grant funding. Sheriff Jerry Colson stated that his 2004 funding of \$41,586.00 must be expended by December 2005. Mr. Colson stated he would like authorization to expend \$32,563.83 on a security system for the Courthouse and \$6,554.00 for AED's at the new jail.

Commissioner Meacham reported that the state is requesting each county contribute a portion of its Homeland Security funding towards a statewide law enforcement information system that could share information between all counties. Commissioner Meacham expressed that he feels the funding would be better used at the county and municipal levels as the state already receives its own funding. Ms. Farster will inquire with the State Office of Homeland Security to clarify information and return later.

The Board authorized Sheriff Colson to purchase the Courthouse security system in the amount of \$32,563.83 and AED's in the amount of \$6,554.00 from the Sheriff's 2004 Homeland Security funding.

Ms. Farster stated that with remainder of 2004 Homeland Security equipment funding she will be expending approximately \$2,000.00 for HAM radio equipment, purchasing a second computer for the Emergency Management Office, and expending \$3,500.00 for sandbags for the Road & Bridge Department.

Commissioner Weickum moved to authorize the Chairman to sign the letter agreement between the Wyoming Office of Homeland Security and Carbon County in the amount of \$6,296.64 for Homeland Security administrative costs. Commissioner Meacham seconded and the motion carried unanimously.

### **LONG BUILDING TECHNOLOGIES**

Dave Kenik and Wade Olsen reported on the progress of the Courthouse heating and cooling project. Shepard Construction is to begin the basement level ceiling replacements next week.

Mr. Kenik presented a Third Quarter 2004-2005 Performance Summary, including preventative and repair maintenance costs.

### **CHEROKEE ROAD**

Robert Linn and Greg Nelson stated concerns regarding the condition of Cherokee Road, including dust abatement, and enforcement of stop signs and speed limits. Mr. Nation replied that the enforcement issues are left to the Carbon County Sheriff's Office and that because an easement agreement has not been signed by the landowners, the road is not officially a county road.

Mr. Linn and Mr. Nelson stated concerns that the easement agreement did not include language that stop signs and speed limit signs will be posted and stated that is why it has not been signed. The men requested the language be added to the easement agreement and stated they would then sign it.

The Board stated it will consult with the county's civil deputy attorney, Tom Thompson on the matter.

### **RECESS**

Chairman Zeiger recessed for lunch at 12:06 p.m. and reconvened at 1:23 p.m.

### **BOARD APPOINTMENT INTERVIEWS**

The Board interviewed Karen Buchanan for consideration of appointment to the Carbon County Senior Services Board in the Baggs and Dixon area.

### **TREASURER**

Commissioner Meacham moved to approve Resolution No. 2005-15, A Resolution of the Board of County Commissioners, Carbon County, Wyoming, Adopting a Statement of Investment Policy with Multi Bank Securities of Michigan and authorize the County Treasurer to invest funding with MBS. Commissioner Weickum seconded and the motion carried unanimously.

The Board authorized the investment because it could be collateralized, and had the highest rate of return.

### **RESOLUTION NO. 2005-15**

#### **A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS, CARBON COUNTY, WYOMING, ADOPTING A STATEMENT OF INVESTMENT POLICY**

### **BOARD APPOINTMENT INTERVIEWS**

The Board interviewed Harriet Carlson and Art Canaday, both for consideration of appointment to the Memorial Hospital Board. Toby Bauer was interviewed for consideration of appointment to the Carbon County Visitor's Council.

## HOMELAND SECURITY

Pam Farster reported that the Homeland Security funding for the statewide law enforcement system would not come from the county funding unless the warning system was severely upgraded, reaching an "orange level".

Commissioner Meacham moved to allow Homeland Security permission to use the funds that have been dispersed but are at the state's disposal to assist the State of Wyoming to use the funding for a law enforcement project. Commissioner Weickum seconded and the motion carried unanimously.

## PLANNING & ZONING PUBLIC HEARINGS

### Case File #05-06

Chairman Zeiger opened a public hearing at 2:00 p.m. to hear Planning & Zoning Case File #05-06. Jonathan Schnal presented the following Case File:

**Case File #05-06 – James J. & Omie Blocker:** Request for a Zone Change from Ranching, Agriculture, Mining (RAM) to Rural Residential Agriculture (RRA-20) on approximately 20 acres. The RRA Zone allows residential and agricultural activities. A parcel of land located in the W1/2 of Tract 3, Mountain View Estates #2, also described as the W1/2 of the SW1/4 NE1/4 of Section 31, T18N, R83W, 6<sup>th</sup> P.M., Carbon County, Wyoming.

There being no public comments, Chairman Zeiger closed the public hearing at 2:02 p.m.

Commissioner Meacham moved to approve Planning & Zoning Case File #05-06, James J. & Omie Blocker's request for a Zone Change from Ranching, Agriculture, Mining (RAM) to Rural Residential Agriculture (RRA-20) on approximately 20 acres. Commissioner Weickum seconded and the motion carried unanimously.

Commissioner Meacham moved to accept Resolution No. 2005-16, A Resolution of the Board of County Commissioners of Carbon County, Wyoming adopting the recommendation of the Carbon County Planning Commission. Commissioner Weickum seconded and the motion carried unanimously.

### **Resolution No. 2005 - 16**

#### **A Resolution of the Board of County Commissioners of Carbon County, Wyoming adopting the recommendation of the Carbon County Planning Commission.**

**WHEREAS**, pursuant to Wyo. Stat. §18-5-202(b), the Carbon County Planning Commission held a public hearing on May 3, 2005, which said hearing was advertised by public notice at least thirty (30) days prior to said hearing; and

**WHEREAS**, at said public hearing, the Carbon County Planning Commission provided the public the opportunity to comment and the Carbon County Planning Commission considered any public comments which were made at said hearing; and

**WHEREAS**, at the conclusion of said public hearing, the Carbon County Planning Commission voted to certify in writing its recommendation to the Carbon County Commissioners to adopt this amendment to the Carbon County Zoning Resolution of 2003 for Carbon County, Wyoming; and

**WHEREAS**, the Carbon County Commissioners, pursuant to Wyo. **Planning & Zoning**

Commissioner moved to accept Planning & Zoning Case File #05-14, Edward P. Reisch & Deanna M. Reisch, Trustees of the Edward P. Reisch Trust dated November 15, 2004, and the Deanna M. Reisch Trust dated November 15, 2004, a request for a Zone Change from Ranching, Agriculture, Mining (RAM) to Residential (RD-6.96) on approximately 6.96 acres and set a public hearing for Tuesday, July 5, 2005 at 2:00 p.m. at the County Courthouse, Rawlins, Wyoming. Commissioner Weickum seconded and the motion carried unanimously.

**BOARD APPOINTMENTS****Senior Services Board**

Commissioner Meacham moved to appoint Karen Buchanan to the Senior Services Board representing the Baggs/Dixon Area for a three-year term expiring April 2008. Commissioner Weickum seconded and the motion carried unanimously.

**Carbon County Visitor's Council**

Commissioner Weickum moved to appoint Toby Bauer to the Carbon County Visitor's Council for a three-year term expiring June 2008. The motion carried with Commissioners Weickum and Meacham voted yes and Chairman Zeiger voted no.

**Memorial Hospital Board**

Commissioner Weickum moved to appoint Art Canaday to the Memorial Hospital Board for a five-year term expiring July 2010. The motion died for lack of a second.

The Board agreed to consider the appointment later in the meeting.

**ECONOMIC DEVELOPMENT CORPORATION**

Harry Lovato and Jay Grabow updated the Board on the Economic Development Corporation's (EDC) recent developments. Mr. Grabow stated that the EDC has been working with the Carbon Mercantile to meet its \$500,000.00 investment goal. Currently \$335,000.00 has been raised.

Mr. Grabow reported that El Paso and CIG Pipelines have committed pipe to take delivery in Sweetwater County. Mr. Grabow is working with Double Eagle Pipeline to have its pipe delivered in Rawlins to benefit Carbon County with the tax dollars. Mr. Grabow stated that Walcott Junction may be an alternate delivery site if the Union Pacific Rail Road is opposed to the delivery in Rawlins.

**ROAD & BRIDGE**

Mr. Nation presented pictures of Cherokee Road taken earlier today. Mr. Nation presented one picture of a vehicle traveling on the road and stated he feels the vehicle did not produce much dust, and that he feels the road is properly maintained, including the shoulders.

**Area Work**

Mr. Nation reported that Road & Bridge, Wyoming T2 and the BLM is currently sponsoring a two-day "blade school" in Rawlins. The various shops are continuing preventative maintenance on several end and belly dumps.

Several flooded roads and plugged culverts are being repaired this and next week. Mr. Nation recently attended a Homeland Security meeting and received authorization to purchase additional sand bags for the county, which have been distributed to Dixon, Saratoga and Elk Mountain county shops.

Mr. Nation requested authorization to apply for State Land and Investment Board Mineral Development Assistance funds. Mr. Nation would like to apply for \$250,000.00 requiring a 50% county match. Mr. Nation stated that the matching funds are already covered by expenditures and labor already made by the county on these roads. The funding would be used for gravel and dust abatement products for highly traveled County Roads due to mineral development.

Commissioner Meacham moved to authorize the Road & Bridge Department to apply for State Land and Investment Board Mineral Development Assistance funds in the amount of \$250,000.00 with an in-kind 50% match by the county to come from already expended funds and labor already completed. Commissioner Weickum seconded and the motion carried unanimously.

**CARBON BUILDING**

Chief Deputy Clerk, Diana Obe, reported on the status of the Carbon Building water damage project. The county has received an insurance payment for last year's water damage at the Carbon Building. Ms. Obe stated Weston Engineering has been monitoring the situation to determine where water is coming in the building and so far the monitoring holes have been dry. Bill Nation and Kandis Fritz also have observed the water patterns and have some idea on where the water was coming from. Ms. Obe stated that the insurance payment should be used immediately to repair the mold and water damage.

Clerk Smith stated since the insurance matter is settled, she would like Mr. Nation and Ms. Fritz to handle the situation, including the mold abatement and future repairs. The Board authorized Mr. Nation and Ms. Fritz to proceed with requesting bids to abate the mold and water damage and to continue monitoring the water situation.

**JEFFREY CENTER BUDGET AMENDMENT**

Clerk Smith reported that she will be advertising for a budget amendment in approximate amount of an additional \$8,000.00 for the Jeffrey Center.

**JAIL COMMITTEE**

Sheriff Colson, Randy Shinkle, and Gary Olson reported on the progress of construction of the new jail. Mr. Olson reported that during the next month tests will be performed on all devices to help determine any problems. The week of June 13<sup>th</sup>, the State Fire Marshal is scheduled to visit and sign off on any pertinent systems and issue a certificate of occupancy, and the following week, the dispatch system is expected to transfer to the new jail.

Mr. Olson stated that he estimates approximately \$700,000.00 in savings to be returned to the county.

Commissioner Meacham moved to extend the substantial completion date of the new jail from February 24, 2005 to June 30, 2005. Commissioner Weickum seconded and the motion carried unanimously.

#### RECESS

Chairman Zeiger declared a recess at 3:48 p.m. to attend a firearms presentation at the new jail and reconvened at 5:20 p.m.

#### **COALBED METHANE COALITION**

Mickey Steward of the Coalbed Methane Coalition presented information regarding split estates and gave handouts for the Board to review. Ms. Steward also further explained the State Land and Investment Board Mineral Development Assistance. She will assist Road & Bridge in making the application.

#### **BOARD APPOINTMENTS**



The Board felt it would be a conflict of interest for one of them to serve and authorized Ms. Smith to select an individual to represent them.
