A regular meeting of the Board of Carbon County Commissioners (BOCC) commenced Tuesday, October 3, 2023, at 9:00 a.m. at the Carbon Building-Courthouse Annex in Rawlins, WY. Attending the meeting were Chairman, Sue Jones, Commissioners John Johnson, John Espy and Byron Barkhurst with Vice Chairman Travis Moore attending virtually.

Chairman Jones called the meeting to order at 9:00 a.m.

### **CONSENT AGENDA**

District in the amount of \$10,000.00; monthly receipts from Planning and Development in the amount of \$27,925.00; and Tax Roll Corrections in the amount of (\$320.70). Commissioner Barkhurst seconded and the motion passed unanimously.

### **EMPLOYEE APPRECIATION**

Gwynn Bartlett, County Clerk overviewed employees having reached years of service milestones in October.

### **ELECTED OFFICIALS & DEPARTMENT HEADS**

#### **Buildings & Grounds**

Jeff Askins, Interim Buildings & Grounds Manager presented a contract to update pneumatic controls at the Jeffrey Center.

Commissioner Johnson moved to approve and authorize the Chairman's signature on the Contract for Services with Dynamic Controls Inc. for Jeffrey Center HVAC upgrades in the amount of \$115,939.00 with the work to be completed by January 3, 2024. Commissioner Espy seconded and the motion passed unanimously.

#### **Sheriff**

Sheriff Alex Bakken introduced Sergeant Jeremiah Rutherford. Sergeant Rutherford is the Employee of the Quarter for the Carbon County Sheriff's Office and presented Sergeant Rutherford with a belt buckle.

Alex Bakken, Carbon County Sheriff provided an update on the patrol and service hours regarding the Town of Hanna MOU as well stating that negotiations have begun again with the Department of Corrections regarding housing sentenced inmates at the county jail.

### **UW EXTENSION – NATIONAL 4-H WEEK PROCLAMATION**

Emily Haver, UW Extension Educator, 4-H Youth Development for Carbon County, presented a Proclamation for National 4-H Week. Chairman Jones read the proclamation.

Commissioner Barkhurst moved to authorize the Chairman's signature on the Proclamation for National 4-H Week. Commissioner Espy seconded and the motion passed unanimously.

### **Public Health**

Megan Cragen, Communicable Disease Outreach Coordinator with Public Health reported on various upcoming shot clinics. She also provided an update on the recent Covid diagnosis. Dr. Abels was present to encourage the public to receive both Covid-19 and flu vaccines.

### **Emergency Management**

Emergency Management Coordinator, Lenny Layman presented a written update to the board.

### **Road & Bridge**

Road & Bridge Coordinator, Kandis Fritz reported she has been working with the WY Department of Transportation to mark county roads as closed on WYDOT's road closure online map during winter months to keep the public safe.

### **Planning and Development**

Kristy Rowan, Interim County Planning Director presented Certificates of Recommended Action and requested a public hearing be scheduled for each. The applicants are Combined Z.C. Case File # 2023-10 and Minor Subdivision Case File #2023-05 – Banjo Sheep Company LLC; Z.C. Case File 2023-11 – Michele and Timothy Farnsworth; Z.C. Case File #2023-12 - Powell Properties LLC; and Z.C. Case File #2023-13 – Alan Peryam.

Commissioner Barkhurst moved to accept the Certification of Recommended Action from the Carbon County Planning & Zoning Commission for Combined Z.C. Case File # 2023-10 and Minor Subdivision Case File #2023-05 – Banjo Sheep Company LLC; Z.C. Case File 2023-11 – Michele and Timothy Farnsworth; Z.C. Case File #2023-12 - Powell Properties LLC; and Z.C. Case File #2023-13 – Alan Peryam and schedule a public hearings for November 7, 2023 at 11:30 a.m. at the Carbon Building – Courthouse Annex in Rawlins, Wyoming. Commissioner Espy seconded and the motion passed unanimously.

### **Clerk**

Gwynn Bartlett, Carbon County Clerk, stated that she received notice that Mr. Robert K. O'Connell has resigned from the Carbon County Predator Management District Board and Larry Benjamin has resigned from the Carbon County Senior Services Board.

Commissioner Espy moved to regretfully accept the resignation of Robert K. O'Connell as an appointed sportsman from the Carbon County Predator Management District Board and Larry Benjamin from the Carbon County Senior Services board and directed the Clerk to advertise for the vacancy. Commissioner Barkhurst seconded and the motion passed unanimously.

Clerk Bartlett presented a board application that she received from Christopher Murry for appointment to the Carbon County Predator Management District Board for approval and appointment.

Commissioner Johnson moved to appoint Christopher Murry to the Carbon County Predator Management District Board as sportsman for an unexpired 3-year term ending December 2023 and then for an additional 3-year term ending December 2026. Commissioner Espy seconded and the motion passed unanimously.

Clerk Bartlett presented a plan change with Blue Cross Blue Shield for board approval and Chairman's signature. The change is to Rx cost saving program to help "true" up a member's accumulators when they use a coupon. Prime Therapeutics is sun setting this program on December 31, 2023, so groups are getting this to remove from the plan. When Paydhealth was added, copay max became moot.

Commissioner Espy moved to approve and authorize the Chairman's signature on the Blue Cross Blue Shield Plan change. Commissioner Johnson seconded and the motion passed unanimously.

Clerk Bartlett presented the Amaze Subscription Agreement for board approval and Chairman's signature.

Commissioner Johnson moved to approve the Amaze Health Subscription Agreement and authorize the Chairman's signature. Commissioner Barkhurst seconded and the motion passed unanimously.



Gwynn reported on statewide Clerk's Association meetings held last week. Counties have received their proportionate share of \$100,000.00 allocated by the legislature for election related training pursuant to Senate File 0153 from the 2023 session. Carbon County's portion was \$3,781.00 which must be used by the end of 2024 and was deposited in the election Fund #155. In addition, while at the Commissioner's Association committee meeting, she heard an update from the WY Retirement System. They plan to propose a 5% increase to the law enforcement retirement plan in October to the appropriations committee.

### **CITIZEN & COMMISSIONER DISCUSSION**

Commissioner Espy hosted the Western Interstate Region with the National Association of Counties (NACo) Board of Directors over the weekend here in Rawlins. The group was surprised that a county of 14,500 people would tax themselves to a point to where we could do improvements and renovations to the Carbon Building and Courthouse. He specifically thanked the voters of Carbon County

Commissioner Johnson discussed the WACO conference that he attended in Casper last week and there was a pretty good discussion on how to recapture funds for Search and Rescue. He stated that there is a significant number of resources that are expended annually for Search and Rescue and he is interested in seeing the end results.

Chairman Jones updated the BOCC on the upcoming legislative Revenue Committee meeting. The primary topic will be property tax breaks for residents, noting that will greatly affect counties so WCCA will monitor closely.

### **EXECUTIVE SESSION**

Commissioner Espy moved to go into executive session at 9:55 a.m. with Clerk Bartlett and Ashley Mayfield Davis to discuss personnel, potential litigation and other matters considered confidential by law. Commissioner Barkhurst seconded and the motion passed unanimously.

Commissioner Espy moved to come out of executive session at 10:50 a.m. noting no action was taken and that the minutes be signed and sealed. Commissioner Barkhurst seconded and the motion passed unanimously.

Vice Chairman Travis Moore left the meeting.

### **MEMORIAL HOSPITAL OF CARBON COUNTY (MHCC)**

Rex Walk, Interim Chief Executive Officer along with Stephanie Hinkle, Marketing, Communications & Foundation Director and Rod Waeckerlin, Trustee provided an update on new services, financials, equipment purchases, community relations and staff education and training. Serner is back in the building working on department billing issues. Mr. Waeckerlin stated they will be temporarily moving to a two meeting per month schedule and the board is starting to investigate a hospital district moving forward. Clerk Bartlett offered to attend an upcoming meeting to explain more about the district process.



### Clerk

Commissioner Johnson moved to authorize the Chairman's signature on the City of Rawlins request for comments on a Special Use Permit from Jack's Body and Fender noting the county has no objection. Commissioner Espy seconded and the motion passed unanimously.

### C.U.W. Case #2012-01 - Power Company of Wyoming, LLC - Conditional Use Permit Wind - Permit Extension Request for the "Chokecherry and Sierra Madre Wind Energy Project"

Ryan Jacobsen, PE, Vice President of Engineering and Construction, with Power Company of WY and general counsel, Lisa Christian presented a request for a Conditional Use Permit (CUP) extension for their Chokecherry & Sierra Madre Wind Energy Project. The original CUP was approved by Resolution No. 2012-43, on October 2, 2012, for C.U. Case File #2012-01 - Power Company of Wyoming, LLC - Conditional Use Permit Wind - Permit Extension Request for the "Chokecherry and Sierra Madre Wind Energy Project" and later extended. Mr. Jacobsen reported they are under construction and plan to construct through late November/early December with 16 miles of roads and 24 turbine pads along with aggregate to the haul road.

Mr. Jacobsen tied the project to the Transwest Express project noting that the project started construction September 19, 2023. Their target date for bringing 1,500 MW transmission in service from WY to Utah is December 2027 with an additional 1,500 MW one year later. He completed the report by noting the county and its local governments have received \$3.123 million in impact assistance funds.

Ms. Christian stated this request to the CUP is to extend the deadline for commencing operations purposes which currently ends September 9, 2024. They are requesting approximately 5 years through all of 2029. The reasons are due to the scale of the project in addition to the fact the likely customers are larger utilities serving metropolitan customers a great distance away, via the Transwest Express project. They believe the 2029 date allows time for both projects to be completed. She added PCW depends on Transwest for service.

Commissioner Johnson stated the BOCC sets policy and takes pride in sticking to its own policies. He asked Attorney Davis to address the issue.

Ashley Davis stated the current Zoning Resolution allows for two, 24-month extensions and this is the 4<sup>th</sup> request by PCW. The initial permit in 2012 with extensions in 2014, 2015 and 2019. At this point the current extension is valid through September 2024 with an additional 2 years through 2026 for the project to become operational and at this point she does not feel the BOCC has the ability to issue any extensions. Ms. Christian stated there were two extensions of the deadline for construction with only one to extend operations. She would like this extension for operations. In her opinion if they want additional extensions they must first begin with Planning & Zoning and then move to the BOCC. P&Z did recommend approval. Ms. Davis replied that the specific prohibition is from the Board issuing additional extensions. Section 6.1, Paragraph 4a addresses subsequent extensions. She interprets this to mean after the original two. Ms. Davis disagreed and thought there are only two extensions allowed and offered to speak with Ms. Christian on how the



project can still proceed. Commissioner Espy asked that the two work through the nuances and report back. Ms. Christian stated this permit is essential to their ability to finance the project and requested this be worked out as soon as possible. She asked that there be no decision at this time and agreed to work with Ms. Davis to move forward expeditiously.

### **EXECUTIVE SESSION**

Commissioner Espy moved to go into executive session at 11:57 a.m. with Clerk Bartlett, Ashley Mayfield Davis, and Kristy Rowan to discuss personnel, potential litigation and other matters considered confidential by law. Commissioner Barkhurst seconded and the motion passed unanimously.

Commissioner Espy moved to come out of executive session at 12:28 p.m. noting no action was taken and that the minutes be signed and sealed. Commissioner Johnson seconded and the motion passed unanimously.

### **Public Hearing - Carbon County Subdivision Regulations Amendments**

Chairman Jones opened a public hearing at 1:30 p.m. to hear Carbon County Planning and Zoning Commission's proposed amendments to the Carbon County Subdivision Regulations as summarized below:

Description of Subdivision Regulations Proposed Amendments:

- The proposed amendments to the following Chapters:
  - Chapter 1-General Provision
  - Chapter 2-Administration and Enforcement
  - Chapter 3-Exemption from Subdivision Regulations
  - Chapter 4-Minor Subdivisions
  - Chapter 5-Large Acreage Subdivisions
  - Chapter 6-Replats
  - Chapter 7-Major Subdivisions
  - Chapter 8-Major Subdivisions – Final Plats
  - Chapter 9-Design and Improvement Standards
  - Chapter 10-Definitions

The proposed amendments include but not necessarily limited to the addition of Large Acreage Subdivisions, further defining Replats, reorganization, reformatting, renumbering, correcting cross-reference errors, formatting inconsistencies, capitalization errors, grammatical and spelling errors, duplication, and removal duplicative sections to improve clarity and ease of administration. Interim Planning Director Kristy Rowen stated that there were no comments received and recommended that the board approve the recommended amendments.

Chairman Jones called for comments for or against the case. There being no comments, she closed the hearing at 1:34 p.m.

Commissioner Espy moved to approve Resolution No. 2023-30, A Resolution of the Board of

County Commissioners of Carbon County, Wyoming adopting Carbon County Subdivision Regulations of 2023. Commissioner Johnson seconded and the motion passed unanimously.

**Resolution No. 2023 – 30**

**A Resolution of the Board of County Commissioners of Carbon County, Wyoming  
adopting Carbon County Subdivision Regulations of 2023.**

**Carbon County Subdivision Regulations of 2023**

**WHEREAS**, Wyoming Stat. Ann. §§18-5-301 through 18-5-315 provide for the adoption and amendment of all subdivision plans and plats and the adoption and amendment of regulations governing such plans and plats by the Carbon County Board of County Commissioners (Board); and

**WHEREAS**, pursuant to Wyo. Stat. Ann. §18-5-202(c), and Wyo. Stat. Ann. §16-3-103(a), the Carbon County Planning and Zoning Commission advertised to hold a public hearing on the adoption and amendment of Carbon County Subdivision Regulations of 2023 on Monday, July 31, 2023, which said hearing was advertised by public notice at least forty-five (45) days prior to said hearing; and

**WHEREAS**, at the Monday, July 31, 2023, public hearing, the Carbon County Planning and Zoning Commission provided the public the opportunity to comment on the proposed regulations and the Carbon County Planning and Zoning Commission considered any comments provided during the notice and comment period along with any comments made at said public hearing; and

**WHEREAS**, at the conclusion of the Monday, July 31, 2023, public hearing, the Carbon County Planning and Zoning Commission voted to recommend amendments to the existing Carbon County Subdivision Regulations and adoption of the Carbon County Subdivision Regulations of 2023; and

**WHEREAS**, the Carbon County Board of County Commissioners provided notice of the scheduled public hearing on the amendments to the existing Carbon County Subdivision Regulations and adoption of the proposed subdivision regulations by two publications in newspapers of general circulation in Carbon County, and provided a notice and comment period of at least forty-five days (45) from the date of publication, such hearing having been held on Tuesday, October 3, 2023; and

**WHEREAS**, at said public hearing on October 3, 2023, the Carbon County Board of County Commissioners provided the opportunity for the public to comment, and the Carbon County Board of County Commissioners considered any comments which were made on the proposed regulations; and

**WHEREAS**, the Carbon County Board of County Commissioners deems it necessary and essential to adopt these Subdivision Regulations for the purpose of promoting and protecting the health, safety and welfare of the inhabitants of Carbon County, Wyoming, by establishing minimum standards for the design and development of subdivisions.

**NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY  
COMMISSIONERS OF CARBON COUNTY, WYOMING:**



That the Carbon County Board of County Commissioners hereby at its meeting held on the 3rd day of October 2023, that these, "Carbon County Subdivision Regulations of 2023," as amended, shall be and the same are hereby adopted and shall be effective October 9, 2023.

**IT IS FURTHER RESOLVED** that all existing or previously adopted subdivision regulations for Carbon County, Wyoming, shall be and the same are hereby repealed and superseded by these "Carbon County Subdivision Regulations of 2023".
