A regular meeting of the Board of Carbon County Commissioners (BOCC) commenced Tuesday, December 5, 2023, at 9:00 a.m. at the Carbon Building-Courthouse Annex in Rawlins, WY. Attending the meeting were Chairman, Sue Jones, Vice Chairman Travis Moore, Commissioners John Espy, John Johnson and Garrett Irene.

Chairman Jones called the meeting to order at 9:00 a.m.

ADDITIONS / CORRECTIONS

Commissioner Johnson moved to approve the agenda as submitted. Commissioner Moore seconded and the motion passed unanimously.

VOUCHERS

Commissioner Espy moved to approve payment to Sunrise Sanitation for \$75.00. Commissioner Moore seconded and the motion passed with all voting for the motion except Commissioner Jones who abstained due to personal conflicts.

Commissioner Espy moved to approve the report of expenditures in the amount of \$427,590.56 for an aggregate total today of \$427,665.56. Commissioner Moore seconded and the motion passed unanimously.

CONSENT AGENDA

Commissioner Espy moved to approve the consent agenda noting any item could be removed for separate action. Clerk Bartlett noted the consent agenda includes the November 21, 2023, regular meeting minutes; monthly receipts from Planning and Development in the amount of \$575.00 and a bond for Doreen Harvey, Clerk/Treasurer for the Town of Encampment in the amount of \$75,000.00. Commissioner Johnson seconded and the motion passed unanimously.

EMPLOYEE APPRECIATION

Gwynn Bartlett, County Clerk overviewed employees having reached years of service milestones in December.

ELECTED OFFICIALS & DEPARTMENT HEADS

Clerk of District Court

Mara Sanger, Clerk of District Court requested to use Bank of Commerce as the depository for 2024.

Commissioner Johnson moved to authorize the Clerk of District Court to use the Bank of Commerce as the depository for 2024. Commissioner Moore seconded and the motion passed unanimously.

Public Health

Dr. Duane Abels, County Health Officer updated the board on COVID, Influenza and other illnesses circulating throughout the county and state. Magen Cragen from CCPH updated the board on her bachelor's degree project, regulations for tattoo parlors. She had been approached by a local tattoo shop wanting such regulations, however there must be an agency to regulate parlors. This project didn't work out so she has redirected her project to the Care Fair planned for April 27, 2024. This is an opportunity for many vendors to come together to assist the public, including the hospital who will offer reduced price blood draws.

Building and Grounds

Jeff Askins, Building Manager requested and received approval of a \$3,295.00 quote from Wyoming Cleaning & Solutions, LLC to refinish the floor in Dorm B at the jail with an epoxy floor coating.

Mr. Askins presented two quotes that he received to install more power and outlets in the small animal barn at the request of the fair board. One quote was from Zumbrennen Electric Inc. In the amount of \$10,091.80 and the other quote is from Acme in the amount of \$7,866.34.

Commissioner Espy moved to approve the quote received from Acme Electric in the amount of \$7,866.34 to install additional power and outlets in the small animal barn at the fairgrounds. Commissioner Moore seconded and the motion passed unanimously.

Planning and Development

Kristy Rowan, Interim Planning and Development Director presented a Certificate of Recommended Action and requested a public hearing be scheduled. The applicant is Z.C. Case File #2023-16 – Larry and Susan Ash.

Commissioner Irene moved to accept the Certification of Recommended Action from the Carbon County Planning & Zoning Commission for Z.C. Case File #2023-16 – Larry and Susan Ash and schedule a public hearing for January 2, 2024, at 11:30 a.m. at the Carbon Building – Courthouse Annex in Rawlins, Wyoming. Commissioner Moore seconded and the motion passed unanimously.

The Land Use Plan online survey is available to the public and Ms. Rowan reported it will close January 5, 2024. Ms. Rowan reported she serves as the board secretary for the WY Planning Association and Cheyenne is hosting the state conference in August 2024.

Clerk

Gwynn Bartlett, Carbon County Clerk, reported that she received sealed bids from both the Rawlins Times and Saratoga Sun to be the county's official publication for 2024. The Rawlins Times quoted \$5.90 per column inch for legal, classified, and standard ads. The Saratoga Sun quoted \$5.75 per column inch for legal, classified, and standard ads. Each also provided publication days and paid subscription numbers for print and online. Lloyd White from the Rawlins Times proposed that the county do a rotating basis.

Commissioner Johnson moved to designate the Saratoga Sun as the Carbon County Newspaper of Record (official publication) for a term of one year beginning January 1, 2024, through December 31, 2024, at a rate of \$5.75 per column inch for legal, classified, and standard ads noting that the bidding process was completed and the Sun had the lowest bid. Commissioner Espy seconded and the motion passed unanimously.

Commissioner Moore stated if the county did choose to use a rotating basis that pricing be fair across the board so the paper being awarded would not be able to price hike on its year.

Gwynn discussed the county's audit noting that it is complete however typically the county must include other entities such as Weed & Pest and the hospital in the audit. One entity's audit isn't expected to be completed for several months and asked if the BOCC would be open to having an unmodified opinion by our auditors which would remove the hospital from this year's audit and allow the county to submit ours timely. The late reporting entity could be included in the future. The BOCC authorized her to proceed this way this year.

Sheriff

Alex Bakken, Carbon County Sheriff, welcomed Commissioner Irene. He provided an update on the Sheriff's Department to include an update on the Saratoga Police Department Emergency Dispatch Assistance MOU. He stated that they are currently approximately halfway through their initial thirty-day assistance term and currently there have been no updates on Saratoga's future course of action.

Sheriff Bakken also stated that a Law Enforcement MOU with the Town of Riverside is still progressing and it would operate similar to the MOU with the Town of Hanna if approved.

Road & Bridge

Kandis Fritz, Road & Bridge Coordinator, reported that County Road 401 and the Jack Creek roads are officially closed for the winter season. Ms. Fritz is meeting with WYDOT and Brush Creek in two weeks to discuss right of way access to the bridge in the Brush Creek area. She and Clerk Bartlett met with Merchant McIntyre (MM); the company hired to help obtain federal funding for various projects. Gwynn reported she will also meet with MM along with Matt regarding cybersecurity and on Friday other first responders regarding public safety funding.

Commissioners

Chairman Sue Jones requested that her signature be ratified on the Dixon Airport IFE Services Agreement that was previously signed on November 28, 2023. This agreement is for an independent fee estimate for the demolition of the north Hangars and connectors.

Commissioner Johnson moved to ratify the Chairman's signature on the Dixon Airport IFE Services Inc. Agreement for Consultant Services for the "Acquire & Demolish North Hangars and Demolish Connectors Project" that was signed on November 28, 2023. Commissioner Espy seconded and the motion passed unanimously.

CITIZEN/COMMISSIONERS DISCUSSION

Commissioner Espy provided an update on NACO's winter board of directors meeting. He reported on intergovernmental relationships between County, State and Federal agencies. NACO is adjusting their Code of Conduct policy due to lack of civility.

Commissioner Johnson reported that he is the Master of Ceremonies for Wreath's Across America for American Legion Auxiliary in Medicine Bow.

Commissioner Irene wanted to thank everybody for giving him a chance to be on the Board of County Commissioners.

SOUTH CENTRAL WYOMING EMERGENCY MEDICAL SERVICES – Irene Archibald

Irene Archibald with South Central Wyoming Emergency Medical Services presented the final version of the Third Amendment to the SCWEMS Joint Powers Board Agreement for board approval and overviewed the changes. Mrs. Archibald stated that the SCWEMS Joint Powers Board approved this amendment at their November 20th meeting.

Commissioner Moore moved to approve the Chairman's signature on the Third Amendment to Restatement of the Joint Powers Agreement, as previously amended, between the Town of Elk Mountain, Wyoming, The Town of Medicine Bow, Wyoming, The Town of Saratoga, Wyoming, The Town of Riverside, Wyoming, , The Town of Encampment, Wyoming, The Town of Hanna, Wyoming, and Carbon County, Wyoming Creating the South Central Wyoming Emergency Medical Services Joint Powers Board. Commissioner Irene seconded and the motion passed unanimously.

EXECUTIVE SESSION

Commissioner Espy moved to go into executive session at 10:23 a.m. with Clerk Bartlett and Ashley Mayfield Davis to discuss personnel, potential litigation and other matters considered confidential by law. Commissioner Moore seconded and the motion passed unanimously.

Commissioner Espy moved to come out of executive session at 10:43 a.m. noting no action was taken and that the minutes be signed and sealed. Commissioner Moore seconded and the motion passed unanimously.

Commissioners

Commissioner Espy moved to authorize the Chairman to sign, negotiate and present an offer of employment. Commissioner Johnson seconded and the motion passed unanimously.

PUBLIC HEARING – Use of Secure Rural Schools Act (Forest Reserve) funds

Chairman Jones opened a public hearing at 10:49 a.m. to hear comments concerning the use of Secure Rural Schools Act (Forest Reserve) funds. Clerk Gwynn Bartlett reported this hearing was advertised in the Saratoga Sun on November 16, 2023. She also reported no written or verbal comments were received by her office.

She did recently meet with various county department heads regarding the use of approximately \$37,000 in forest reserve funding noting what the county can utilize these for and that the expenses can only be in the proportionate share to be used in the forest and in this case that will be 100%. Sheriff Bakken presented the recommendation to continue to pay for Search & Rescue stipends and to purchase two, likely used snowmobiles with accessories and a trailer if needed and funds allow. Other departments agreed with this and he presented statistics on the number of snowmobiles in the area. He also requested the approval include accessories and a trailer and noted these could be utilized for patrols as well as search & rescue and solely in the forest.

Chairman Jones called for comments and there being none, Chairman Jones closed the hearing at 10:59 a.m.

Commissioner Espy moved to authorize the use of Secure Rural Schools Act (Forest Reserve) funds for the purchase of snowmobiles, related accessories, and a trailer to be used in the forest and for paying volunteer stipends for searches in the forest. Commissioner Moore seconded and the motion passed unanimously.

Sheriff Bakken reported two deputies are currently looking for used sleds and the BOCC asked him to proceed by contacting one of them once he finds the ones he would like to purchase.

MEMORIAL HOSPITAL OF CARBON COUNTY (MHCC)

Rex Walk, Interim Chief Executive Officer along with Stephanie Hinkle, Marketing, Communications & Foundation Director introduced Scott Miller, the new Interim Chief Financial Officer and provided an update on new services, financials, equipment purchases, community relations and staff education and training.

Providers joining their team are Sophie Baxter, PAC and Julie Ann Freeman, FNP-C and both were present and introduced. Peggy Lake will be retiring soon as well. Mr. Walk discussed the Oracle-Cerner issues since their computer transition in September 2022.

Chairman Jones opened a public hearing at 11:38 a.m. to hear Planning & Zoning Z.C. Case File No. 2023-14, Carlene Sjoden, Randal, and Donna Sjoden's request for a Zone Change from Ranching, Agriculture and Mining (RAM) to Forestry Production and Seasonal Recreation (FPSR-7.5) on approximately 7.5 acres. The FPSR Zone is intended to be applied to areas of the County in which timber production and seasonally accessible recreation uses are the desirable predominant uses and is located approximately 24 miles southeast of Saratoga off WY HWY 130 east of the Ryan Park Subdivision. Kristy Rowan, Interim Planning Director presented the case file.

WHEREAS, pursuant to the Carbon County Zoning Resolution of 2015, as amended, and Wyo. Stat. Ann. §18-5-202(b), the Carbon County Planning and Zoning Commission held a public hearing on Monday, November 6, 2023, which hearing was advertised by public notice at least thirty (30) days prior to said hearing; and

WHEREAS, at the Monday, November 6, 2023, public hearing, the Carbon County Planning and Zoning Commission provided the public the opportunity to comment and the Carbon County Planning and Zoning Commission considered any public comments which were made at said public hearing; and

WHEREAS, at said public hearing on December 5, 2023, the Carbon County Board of County Commissioners provided the opportunity for the public to comment and for the Carbon County Board of County Commissioners to consider any comments which were made on the proposed amendment; and

WHEREAS, the Carbon County Board of County Commissioners in considering the proposed amendment have also reviewed and considered the Carbon County Comprehensive Land Use Plan, as amended; and the Carbon County Zoning Resolution of 2015, as amended; and

CARBON COUNTY LAND USE PLAN

Doug Boyd with WLC Engineering and Bree Burton with Y2 Consultants provided an update on the Carbon County Land Use Plan. They discussed the members of the Steering Committee and previous meetings held. The survey for county residents has gone live and 17 surveys have been completed to date and over 200 visits to the website. The big push over the next month is to get surveys completed to help drive the amendments to the land use plan. Y2 is meeting monthly with the steering committee and their next meeting is December 27, 2023. Discussion was held on how to proceed with mailing out postcards to over 2000 addresses with 992 being out of state and 1690 in state. Mrs. Burton is anticipating sending out the postcards next week, The out of state addresses are primarily the big corporate ranches. Chairman Jones and Commissioner Johnson recommended that everyone outside the incorporated municipalities receive the postcard. Commissioner Johnson also asked how residents who live inside municipalities are being notified. Mrs. Burton stated that it is posted on the county website as well as the county Facebook page and in the local newspaper.
