A regular meeting of the Board of Carbon County Commissioners (BOCC) commenced Tuesday, March 18, 2025, at 9:00 a.m. at the Carbon Building-Courthouse Annex, Rawlins, WY. Attending the meeting were Chairman, R. Travis Moore, Vice Chairman Gwynn Bartlett, Commissioners John Johnson, John Espy and Sue Jones.

Chairman Moore called the meeting to order at 9:00 a.m.

ADDITIONS / CORRECTIONS

Chairman Moore added Clerk of District Court for an update, Road and Bridge for Bridge Replacement (BROS) Recon Contracts, and Health Equity Changes to Health Reimbursement Arrangement Plan Amendment under County Clerk.

Commissioner Johnson moved to approve the agenda as amended. Vice Chairman Bartlett seconded and the motion passed unanimously.

CONSENT AGENDA

Commissioner Espy moved to approve the consent agenda noting any item could be removed for separate action. Clerk Smith noted the consent agenda includes the March 4, 2025, regular meeting minutes; monthly receipts from the Carbon County Clerk in the amount of \$13,978.75 and Clerk of District Court in the amount of \$4,420.00; and a bond for Janeil Kay Ebell, Deputy Treasurer for Carbon County in the amount of \$10,000.00. Commissioner Jones seconded and the motion passed unanimously.

ELECTED OFFICIALS & DEPARTMENT HEADS

Clerk of District Court

Mara Sanger, Clerk of District Court provided a departmental update including information on notifications to jurors. She stated she is going to start using the Alert Sense system as an additional means to summon jurors on upcoming trial dates.

Buildings & Grounds

Jeff Askins, Buildings and Grounds Manager, requested and received approval to fill a vacancy within his department.

Assessor

Renee Snider, Carbon County Assessor, requested and received approval to fill a vacancy within the Assessor's Office.

IT

John Rutherford, County Fire Warden and Matt Webster, Carbon County IT Director requested to donate two surplus dishes to the Carbon County Fire Protection District at the fire district's cost.

Commissioner Johnson moved to approve the donation of an antenna to the Carbon County Fire Protection District. Vice Chairman Bartlett seconded and the motion passed unanimously.

Road & Bridge

Kandis Fritz, Road & Bridge Coordinator presented pay application #1 for commissioner review and approval.

Vice Chairman Bartlett moved to authorize the Chairman's signature and approve payment of Pay Application #1 for the Medicine Bow River Bridge Resurfacing in the amount of \$162,380.00 Commissioner Espy seconded and the motion passed unanimously.

Ms. Fritz discussed County Rd. 270 closure for bridge repairs. Landowners and emergency services will be notified prior to the closure.

Ms. Fritz received contracts for the BROS projects for the recon work for bridges on County Road 680 and County Road 3 pending legal review. The match will be paid from the road fund.

Commissioner Espy moved to approve any Commissioner signature on the BROS Recon Contracts for bridges on County Road 680 and County Road 3 pending legal review. Vice Chairman Bartlett seconded and Commissioner Johnson opposed, and the motion passed.

Sheriff

Alex Bakken, Carbon County Sheriff recognized Brynna Grundman as employee of the quarter. Sheriff Bakken recognized Wyoming Highway Patrol for a recent stop that discovered the recovery and seizure of a large amount of ammunition. He also provided an update on the unified dispatch operations.

Attorney

Ashley Davis, Deputy County Civil Attorney, introduced Garrett Parker who is a student and intern working in their office.

Fire

John Rutherford, County Fire Warden provided an update for the department and stated they are working on updating contracts with the fire district. He stated the district applied for \$155,000.00 grant for a mobile training unit. He commended Commissioner Jones and the board for their support for the district.

Clerk

Lisa Smith, County Clerk, presented board applications that she has received for the Carbon County Senior Services Board.

Commissioner Johnson moved to appoint Joe Lansing as the Elk Mountain representative and reappoint Denise Ashline as the City of Rawlins representative and reappoint Judith Wohl as the Town of Medicine Bow representative all for the Carbon County Senior Services Board and all

for a 3-year term ending March 2028. Commissioner Jones seconded and the motion passed unanimously.

Clerk Smith requested approval of the Health Equity Health Reimbursement Arrangement Plan Amendment to shut off the autopay function and allow all medical, dental, vision, Rx, and over the counter items to reflect the Flex Spending Account functions, pending legal review.

Vice Chairman Bartlett moved to approve the Health Equity Health Reimbursement Arrangement Plan Amendment pending legal review and to authorize any commissioner's signature. Commissioner Espy seconded and the motion passed unanimously.

Commissioners

Ashley Davis, Deputy County Civil Attorney, is drafting a letter to the Bureau of Land Management regarding the Lucky Star Transmission Line Project for board approval and Chairman's signature.

Commissioner Espy moved to approve and authorize the Chairman's signature on the comment letter to the Bureau of Land Management regarding comments on the Lucky Star Transmission Line Project pending legal review. Commissioner Johnson seconded and expressed concerns about the rerouting of the transmission line which will bring it closer to the river and asked it to be incorporated into the comments. Commissioner Jones inquired about the permitting process and the timeframe. Commissioner Espy asked Kristy Rowan to work with the BLM on notifications regarding future EAs. The motion passed unanimously.

CITIZEN & COMMISSIONER DISCUSSION

Commissioner Johnson thanked the Carbon County Fire District for responding to a fire at his property.

Vice Chairman Bartlett stated she has been attending Hospital Board meetings and updated on the GIS RFP interviews and hopes to have a recommendation by the second April meeting. She mentioned the masonry project is finally moving forward after receiving three bids. A contract is being drafted currently for approval at a future meeting. The courthouse will be completed first so the lawn can be completed during the summer. The bid does not cover the retaining wall on the east side of the courthouse. Funds have already been allocated for this project including the retaining wall. Chairman Moore is asking that they look at the veteran's memorial on the corner of the courthouse as well.

Commissioner Espy provided an update on his trip to the NACO Conference and his meeting with Senator Barrasso. He met with Senator Lummis's staff, Representative Hageman and the Energy Secretary, as well as U.S. Forest Service and Department of Interior. He discussed the meeting related to public lands and NEPA studies and the future of the rules surrounding NEPA.

Commissioner Jones stated the GIS RFP experience was interesting but complicated and appreciates the education the committee provided.

Chairman Moore thanked Commissioner Espy for his participation and representing the county and Wyoming at NACO.

EXECUTIVE SESSION

Commissioner Espy moved to go into executive session at 10:09 a.m. with Clerk Smith, Ashley Mayfield Davis, and Sarah Chavez Harkins to discuss personnel, potential litigation and other matters considered confidential by law. Vice Chairman Bartlett seconded and the motion passed unanimously.

Commissioner Espy moved to come out of executive session at 11:09 a.m., noting that no action was taken and that the minutes be signed and sealed. Vice Chairman Bartlett seconded and the motion passed unanimously.

MEMORIAL HOSPITAL OF CARBON COUNTY (MHCC)

Gerald Patton, Chief Executive Officer and Stephanie Hinkle, Chief Operating Officer for MHCC and Rod Wackerlin provided an update on the current hiring process and the hospital's audit. Ms. Hinkle gave an update on the new surgeon Dr. Singleton. She explained the new award for the \$50,000.00 for Lifepack Systems. Mr. Wackerlin asked to attend an April executive session.

ADJOURNMENT

Commissioner Espy moved to adjourn the meeting at 11:15 a.m. Commissioner Johnson seconded and the motion passed unanimously.
