A special meeting of the Carbon County Board of Commissioners commenced Tuesday, August 12, 2025, at 10:45 a.m. at the Carbon Building – Courthouse Annex in Rawlins, WY. Attending the meeting were Chairman, R. Travis Moore, Vice Chairman Gwynn Bartlett, Commissioners John Johnson, John Espy and Sue Jones.

Pursuant to Wyoming State Statute §39-13-102 and §39-13-109(b), and Chapter 7 of the State Board of Equalization Rules, the purpose of the meeting was to meet as the Carbon County Board of Equalization (BOE) to consider action on filings received in 2025 property tax assessment appeals.

Chairman Moore called the meeting to order at 10:45 a.m. for Docket Appeal No. 2025-BOE01, HF Sinclair Oil Corporation, Petitioner vs. the Carbon County Assessor, and Docket Appeal No. 2025-BOE02, Wyoming Renewable Diesel Company LLC, Petitioner vs. the Carbon County Assessor.

Deputy County Attorney Ashley Davis presented two Motion and Orders to dismiss Docket Appeal No. 2025-BOE01 and Docket Appeal No. 2025-BOE02 due to formal withdrawals received from Jeffrey R. Cohen on July 22, 2025.

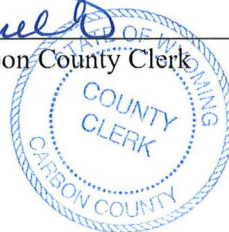


There being no further business, Chairman Moore adjourned the meeting at 10:48 a.m.
