A regular meeting of the Board of Carbon County Commissioners (BOCC) commenced Tuesday, October 21, 2025, at 2:00 p.m. at the Elk Mountain School in Elk Mountain, WY. Attending the meeting were Chairman, R. Travis Moore, Vice Chairman Gwynn Bartlett, Commissioners John Espy, John Johnson and Sue Jones.

Chairman Moore called the meeting to order at 2:00 p.m.

ADDITIONS / CORRECTIONS

Chairman Moore removed Courthouse Landscaping Bid Request from the agenda.

Commissioner Johnson moved to approve the agenda as amended. Vice Chairman Bartlett seconded and the motion passed unanimously.

CONSENT AGENDA

Commissioner Espy moved to approve the consent agenda, noting that any item could be removed for separate action. Clerk Smith noted the consent agenda includes the minutes from the Commissioner's meeting held on October 7, 2025; and a bond for Karen R. Heath, Treasurer for

the Town of Medicine Bow in the amount of \$100,000.00. Commissioner Johnson seconded and the motion passed unanimously.

ELECTED OFFICIALS & DEPARTMENT HEADS

Emergency Management

Lenny Layman, Emergency Manager provided an update on the Wyoming PBS Alert System. He stated this system doesn't coordinate with local Emergency Management Coordinators and undermines the local programs. For those individuals who sign up for this alert system instead of the local alert system in the event of an emergency, those individuals may not receive all necessary information. He recommended Wyoming PBS coordinate with local Emergency Managers and their alert systems. It's also important that we're not competing for Homeland Security funding for these systems.

Sheriff

Alex Bakken, Carbon County Sheriff provided an update for his office. The Higher Education Center is offering Spanish as a second language class for law enforcement and the community for those interested.

He provided an update on the Memorandum of Understanding with the Town of Baggs to increase law enforcement present in their community.

Road and Bridge

Kandis Fritz, Road and Bridge Superintendent gave an update that her newest employee passed his CDL testing and she now has 11 operators in her department.

Ms. Fritz stated that the bridge over County Road 660 just went through a review process and she will be providing an update at the next meeting.

Ms. Fritz provided information on road damage to County Road 603 in the Baggs area. The damage has to be addressed immediately due to safety concerns and she closed this road yesterday. She will be fixing it well enough for winter and will be coming back in the spring to request it be repaired correctly.

Clerk

Lisa Smith, Carbon County Clerk, presented the Blue Cross Blue Shield Administrative Services Agreement for Carbon County Employees for approval. This agreement has been updated to reflect the new plan year through September 30, 2026

Vice Chairman Bartlett moved to approve and authorize the Chairman's signature on the Blue Cross Blue Shield of Wyoming Administrative Services Agreement for a period of October 1, 2025, through September 30, 2026. Commissioner Jones seconded and the motion passed unanimously.

Attorney

Ashley Davis, Deputy County Civil Attorney, presented a lease agreement for board approval and Chairman's signature. Encampment Mayor Shannon Fagan is wanting to be a new tenant for a retail property that she is dedicating to have it serve the community of Encampment.

Commissioner Espy moved to approve and authorize the Chairman's signature on the Lease Agreement between Public Health and the Town of Encampment for office space for Beacon in the Wind, Shannon Fagen. Commissioner Johnson seconded and the motion passed unanimously.

CITIZEN/COMMISSIONERS DISCUSSION

Commissioner Johnson said it's great to be back and in person.

Vice Chairman Bartlett went to the hospital open house last week and said the attendance was pretty low but good information. She will be attending their meeting Thursday. She stated herself, Kandis and Lisa are still working with Merchant McIntyre to identify grants and recently applied to the RTAP grant for Seminoe Road engineering.

Chairman Moore mention the pathway's west application period extended the one year period requirement. The government shut down has delayed any response from Senator Barraso's office. He stated that he met with Representative Thayer and hopes that at the state and federal levels that all energy production are important at this time.

EXECUTIVE SESSION

Commissioner Espy moved to go into executive session at 2:46 p.m. with Clerk Smith and Ashley Mayfield Davis to discuss personnel, potential litigation and other matters considered confidential by law. Commissioner Johnson seconded and the motion carried unanimously.

Commissioner Espy moved to come out of executive session at 3:24 p.m. noting no action was taken and that the minutes be signed and sealed. Commissioner Johnson seconded and the motion carried unanimously.

Commissioner Espy moved to authorize the chairman's signature on a letter from the board to a concerned constituent. Vice Chairman Bartlett seconded and the motion passed unanimously.

ADJOURNMENT

Commissioner Espy moved to adjourn the meeting at 3:25 p.m. Vice Chairman Bartlett seconded, and the motion passed unanimously.
